**RESOLUTION OF THE BOROUGH OF ST. LAWRENCE AUTHORIZING A REQUEST
FOR A GRANT FOR PA SMALL WATER AND SEWER PROGRAM FROM THE
COMMONWEALTH FINANCING AUTHORITY**

WHEREAS, the Borough of St. Lawrence, of Berks County, plans on doing a small water and sewer project totaling \$290,560.50.

WHEREAS, the Borough of St. Lawrence is requesting a grant from the Commonwealth Financing Authority for the PA Small Water and Sewer Program to be used for the lining of aging sewer lines prone to water infiltration with cure-in-place piping.

WHEREAS, the Borough of St. Lawrence is seeking a grant for the total amount of the project of \$290,560.50.

WHEREAS, the Borough of St. Lawrence is responsible for 15% (fifteen percent) of the total cost of \$290,560.50. If awarded, \$43,584.08 will be the sole responsibility of the Borough of St. Lawrence, with the grant total being \$246,976.42.

WHEREAS, the Borough of St. Lawrence does hereby designate Borough Manager, Allison Leinbach, and Roadmaster, Derrek Rhoads, as official(s) to execute all documents and agreements between the Borough of St. Lawrence and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.

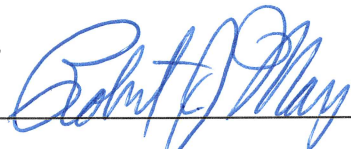

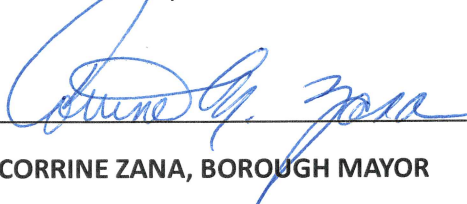

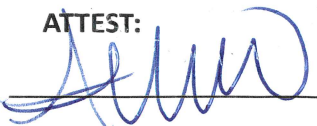
