

## **BOROUGH OF ST. LAWRENCE RESOLUTION 919-2025**

### **RESOLUTION OF THE BOROUGH OF ST. LAWRENCE AUTHORIZING THE APPOINTMENTS OF AMANDA MUSO AND ALLISON LEINBACH AS DEPUTY TAX COLLECTORS FOR THE BOROUGH OF ST. LAWRENCE, BERKS COUNTY, PENNSYLVANIA**

**WHERAES**, Section 5511.22 of the Local Tax Collection Law, provides that a tax collector may, with the approval of a taxing district, deputize in writing one or more deputy tax collectors, who, when deputized, shall be authorized to receive and collect any or all of the taxes in like manner and with the authority as the tax collector appointing them. Any tax collector, appointing any deputy collector, shall be responsible for and account to the taxing district for all taxes received or collected by his/ her deputy/s and;

**WHEREAS**, the duly elected tax collector of the Borough of St. Lawrence, Berks County, Susan Eggert, desires to appoint two deputy tax collectors to serve as tax collectors for the Borough of St. Lawrence, Berks County, should he/she be unable to perform the duties of tax collector; and

**WHEREAS**, Susan Eggert, Tax Collector, of the Borough of St. Lawrence, desires to appoint Amanda Muso and reappoint Allison Leinbach as Deputy Tax Collectors for the Borough of St. Lawrence, Berks County; and

**WHEREAS**, Section 5511.22 of the Local Tax Collection Law provides that the tax collector for a jurisdiction may appoint a deputy tax collector with the approval of the tax collector's surety; and

**WHEREAS**, the Borough Council desires to appoint Amanda Muso and reappoint Allison Leinbach as Deputy Tax Collectors until the termination or resignation of either position or party

**BE AND IT IS HEREBY RESOLVED** that the Borough Council and Tax Collector Susan Eggert of the Borough of St. Lawrence, Berks County, Pennsylvania, desires to appoint Amanda Muso and reappoint Allison Leinbach as Deputy Tax Collectors


