

BOROUGH OF ST. LAWRENCE
SPECIAL MEETING MINUTES
Wednesday, July 23, 2025

CALL TO ORDER: The meeting of the St. Lawrence Borough Council was called to order at 7:00 PM by Council President Robert May.

ROLL CALL: Council President Robert May did roll call; the following members were present; Council President Robert May, Council Vice President, Dave Eggert, Member, Michael Fritz, Member, Rev. D. Michael Bennethum, Member, Steve Geibel, Allison Leinbach, Borough Manager /Treasurer, Engineer, Pamela Stevens, and Borough Secretary Amanada Muso. Gregory Zawilla, Member, Warren Lubenow, Member, Mayor Corrie Zana, Roadmaster Derrek Rhoads, and Borough Solicitor, Joan London, were absent from tonight's special meeting.

APPROVAL OF THE MINUTES: The minutes from the July 10, 2025, meeting were presented to the Council for review. There were no corrections or additions.

MOTION: Rev. Bennethum made the motion to approve the minutes as presented; seconded by Dave Eggert; all were in favor and so the motion carried.

PUBLIC COMMENT:

There was no public comment.

EXECUTIVE SESSION:

There was no executive session needed at tonight's meeting

NEW BUSINESS:

Multimodal Grant- Updated grant request and added sidewalks along St. Lawrence Ave in front of National Cleaners and the Car Stereo Shop, as well as adding new curbing to the sidewalks at Turkey Hill. Sidewalks will also be added along the Antietam Valley Shopping Center for pedestrian safety, as well as easy access to the shopping center. This will connect both sides of the road for pedestrian safe travel.

The new plans were discussed in detail, along with the associated costs. It was explained that, with this grant, the Borough has a zero percent match. Regardless of the amount the Borough receives, we will not have to contribute any funds towards it. We are hopeful that we will be granted the total amount of \$1,519,336.00 to complete the project. If we do not receive the entire amount, the Antietam Valley Shopping Center sidewalks will be the first to be cut. This was decided because there are sidewalks on the opposite side of the road, unlike in other areas.

MOTION: To Approve Resolution 918-2025 - Resolution of the Borough of St. Lawrence Authorizing An Updated Request For A Pennsylvania Multimodal Transportation Fund Grant From the Commonwealth Financing Authority
Dave Eggert made the motion to approve Resolution 918-2025; seconded by Rev. Bennethum; all were in favor and so the motion carried.

Motion to adjourn was made by Dave Eggert seconded by Rev. Bennethum; all were in favor and so the special council meeting concluded at 7:13 PM.
