#### **EXHIBITOR CONTRACT**

#### 1. Exhibition Space

- A. Alamo Hero Con will provide Exhibition space as detailed in Exhibitor Booth Selection. All single vendor booth spaces are 10 x 10 and include two (2) vendor badges for entry.
- B. Alamo Hero Con provides the equipment as listed in the "EXHIBITOR BOOTH SELECTION" with each booth purchased. All additional equipment and furnishings are the responsibility of the Exhibitor. NO PIPE AND DRAPE WILL BE PROVIDED.
- C. Exhibitor will keep areas clean and are responsible for any damage to venue. Exhibitor agrees to leave the area "broom clean" at the close of the show.
- D. Alamo Hero Con reserves the right to change booth locations at the promoter's discretion.
- E. No smoking or alcohol is allowed in the event venue at any time.

## 2. <u>Display and Merchandise Regulations</u>

- A. Exhibitor agrees to remain set up for all hours of the Con. No early breakdown is allowed without the prior consent of Alamo Hero Con.
- B. Any damage caused to the building or booth furnishings by the Exhibitor is the sole responsibility of the Exhibitor.
- C. Exhibitors are prohibited from blocking or interfering with other Exhibitors.
- D. Exhibitor agrees not to sell or distribute any adult material.

#### 3. Sales Tax

Exhibitors are responsible for collecting Texas Sales Tax (8.25%)

#### 4. Payment for Exhibition Space

- A. Exhibitor understands Exhibitor's payment policy and agrees to pay the fees as listed on the Exhibitor Booth Registration Form.
- B. Payments will be taken via PayPal invoice.

## Security

- A. Exhibitor is responsible for their own security during show hours, however Alamo Hero Con agrees to provide security during show load-in and load-out, and a security presence during show times.
- B. Alamo Hero Con and Shrine Auditorium are not responsible for any theft or loss.

## 6. <u>Liability</u>

- A. The Exhibitor agrees to protect, keep, and save Alamo Hero Con, the promoter of the event, forever harmless from any damage(s) or charge(s) imposed for violations of any ordinance or regulation by the Exhibitor, his employees or agents, as well as failure to comply with the terms and agreements of this contract. Further, Exhibitors shall at all times protect, indemnify, save, and keep harmless Alamo Hero Con against and from any loss, cost, damage, liability, or expense which arises out of or from or by reason of any act or omission of the Exhibitor, his employees, or agents.
- B. In the event that Shriner Auditorium or any part of the exhibit area thereof is unavailable, whether for the entire event or a portion of the event, as a result of fire, flood, or another such cause, or as a result of government intervention, malicious damage, acts of war, strike, labor disputes, riot, acts of God, or agency which Alamo Hero Con has no control, or should Alamo Hero Con decide that because of any such cause it is necessary to cancel, postpone, or re-site the show, or reduce installation time, exhibit time, or move out time, Alamo Hero Con shall not be liable to indemnify or reimburse the Exhibitor in respect of any damage or loss, direct or indirect, arising as a result thereof.
