Letter from FEMA: Flood Insurance study and Flood Insurance Rate Map have been completed for our community. FIS and FIRM will become effective on June 15, 2022, and by this date The Department of Homeland Security's FEMA is required to approve the legally enforceable floodplain management measures that our community adopts in accordance with Title 44 Code of Federal Regulations Section 60.3.

- 8. Supervisor- Bob- American Plumbing is going to replace a new urinal in the men's bathroom as soon as they get it in. Jays will continue to do our lawncare and he will do a clean up at the Cemetery. GFL will drop a 30-yard dumpster at the cemetery, it should only be used for cemetery.
- 9. Water and Sewer: Bob- We received a response from the Tribe, they mentioned getting together with us early next week. The proposal from the Tribe biggest concern is the gallons per minute vs the pressure vs the volume. 36,000-gallon tank on our property. Rhode will be out there as soon as the frost laws are lifted. Grinder and water meters maintenance and repairs of these pumps. We do not have a policy in place. We have two choices, either the homeowner is responsible or when we begin billing, we charge a line item. Slush fund. How much do we charge? There are brands out there between \$2500 and \$5500. It might not have the same pressure if we go with something other than what's out there now. Sue will research what other Municipalities do. Adam, Chris and Bob looked at the proposal from the 25 gallons per minute, Tribe supplies us with what is needed. 3 months. My suggestion is to at least let us hook up to the sewer, because some will need septic removed to install the water. The Grinder pumps, we had a batch delivered in fall and a batch will be here in May.
