4. Talk about your involvement with local non-profits, patricianly any LGBTQ non-profit organizations
5. Explain why you deserve this scholarship

GUIDELINES FOR LETTERS OF RECOMMENDATION

Please submit a total of three (3) letters of recommendation. Two (1) should come from academic sources and the additional one (2) should come from a personal source. Please use the following prompts when drafting your letter.

1. How long have you known the applicant?
2. In what capacity?
3. What leadership qualities come to mind when you think about the applicant?
4. Why should we select this applicant for the 2024 United Waves Scholarship?

GUIDELINES FOR SELECTION

The winner (s) of this round of scholarships will be selected by a committee vote and will be announced on May 11, 2024 and the scholarship will be awarded for the Fall 2024 semester. All decisions are final. Dates subject to change.
