# 2. Consent Agenda

2.1 Approval of the Minutes of May 28 MAD Board Meeting, and June 5 MAD Emergency Board Meeting were postponed pending copies re-emailed to board.

## 3. Public Comments:

3.1 Board congratulated and welcomed new member Rick Gano. He will be sworn in at a July 9, 2019 MAD board meeting.

#### 4. New Business

4.1 Board Vacancy Update: TS received enough votes that Clackamas County Elections sent her letter asking if she wanted to retain her seat. She said yes. Board congratulated her on her re-election to the board and thanked her warmly for her continuing service.

## 5. Old Business

5.1 Approve Proposed Rate Changes: PB moved to approve the proposed rate changes submitted to the Board previously. NL seconded. Motion carried, unanimously, 4-0.

## 6. Committee Reports and Updates

6.1 Financial Update: Columbia Bank Balance: \$44,378.81, QB Balance: \$26,586.64, LGIP Account Balance (approximate since accountant doesn't have read-only access to LGIP account): \$442,270.82, Scholarship Fund: 500.00, Petty Cash: 62.01=Total of \$513,798.28. Total Outstanding: \$17,792. 19. Total balance before next payroll: \$26,586.64. Total balance after next payroll: \$14,586.64.

PB will check with LGIP regarding the hang-up of giving accountant read-only access to the account.

NL observed that getting checks signed is a problem due to periodic unavailability of authorized signers (board members). TS and NL agreed to become signers of checks. NL moved to remove

- outgoing Board member Marilyn Bloch from the MAD Columbia Bank account and add all Board Members: Neal Lucht, Teresa Steinbock, Paula Beck, Claire Ferlan and Rick Gano. PB seconded. Motion carried, unanimously, 4-0.
- 6.1.1 Scholarship Fund: MG announced a generous \$500 gift to the Scholarship Fund. NL asked if it were a separate fund. MG said no, but the scholarship fund has been separated in the Quickbooks ledger. MG said a goal to raise \$5000-\$10,000 for the Scholarship Fund is doable. NL said that a sub-committee should be formed to oversee that effort and 1-2 community members should be appointed to serve on that board with Board Members.
