4. New Business

4.1 Bookkeeping: HA said based on earlier discussion during the Board Retreat she moved to direct MG to pursue an alternative accountant so MAD can cancel NowCF. - 5.2 Financial Report: The Financial Reports were included in the Board Packet that was emailed and uploaded to Google Drive prior to the Board Meeting. CF asked if the \$559,000 balance will be enough for the HVAC. MG told the BOD the tax revenue funds have not come in yet. The bulk of the tax revenue comes in November. MG said the tax assessor is certified over \$650,000 and the budget is \$591,000. Debbie, the bookkeeper, has been working on the Kids' Club, which is netting a profit but may not reflex in the current financial reports.
- 5.3 Operations-Management Report: MG said things are going well. She said the Pumpkin Plop was very well attended. FOMP and RG will be at the Downtown Molalla Trick or Treat handing out free family day passes and candy. JS will call Jill at the Chamber for a location. HA asked about attendance and staffing on Sundays. MG told the BOD MAC is open for Sundays at 11am with Inflatable Swim and then Family Swim.
