- 4.3 Pool Plaster update: We received a 10-day demand letter dated 07-14 for the \$10,000 still owing. They contacted Julie and she re-sent the list of complaints we have. The response was they are going to contact their Subcontractors and get back to us in a week, no response has been received. When Brody from Anderson came out we pointed out the purple spots in the plaster that were not there before the sanding, and he stated that it was

Manganese in our water that was causing it. We ordered a test kit, and our water has 0.03 manganese in the water and so we can rule that out as the cause. Our next step would be to contact the CCB website and research the process of filing a complaint. Barbara makes a motion to have Julie research what we need to start a claim with the Contractors Board and write a letter to start the process. Neal seconds. Motion Passes with Lucht, Appleton, Moore and Melby voting "aye" (4-0)
