	2. I agree to give my cat appropriate time to adjust to his/her new home using the 3-3-3 Procedure: • 3 days to decompress. 3 weeks to feel comfortable & learn routines. 3 months to feel at home and settled in.
	3. I agree that my cat will be a family companion and live in a private residence.
	4. I agree to never declaw my cat and will contact Tiplings if scratching becomes an issue.
	5. I agree to supervise all interactions between my cat and young children.
	6. I agree that this cat will not be given as a surprise gift, given away or sold. I agree to not transfer this cat to another person without written permission from Tiplings
	7. If I move, I agree to make every effort to find a place where my cat will be allowed.
	8. Should I no longer be willing or able to keep this cat, I agree to return the cat to Tiplings.
	9. Should I have a question or a concern regarding this cat, I agree to contact Tiplings and give them 2 business days to respond.
	10. I agree that any and all expenses incurred after adoption are entirely my responsibility.
	11. I agree that Tiplings will not be held responsible for any accidents, injuries or illness arising from the adoption of my cat. Tiplings does not guarantee the health or temperament of this cat.
	12. I understand that Tiplings does not refund the adoption fee for a returned cat.
	13. I agree to allow my (and my family's) image and my cat's image to be used by Tiplings without requiring permission or compensation.
