As the President of the Phi Kappa Sigma Educational Fund, I would like to thank you for your past generosity and to let you know our plans for the future.


The Educational Fund was founded in 1953 and, up to the year 2000, primarily gave out scholarships. *In 2000, we started to fund some of the educational programs such as the Men of Honor*

Program and the Male College at the Grand Chapter. In 2019 and 2020, we gave \$100,000 in undergraduate scholarships each year. We gave \$40,000 to the Men of Honor Program. We paid our share of the publication Maltese Cross to advertise our scholarship winners and to thank our donors. We also granted funds for the purchase of a database to capture alumni information.

We are giving \$100,000 in scholarships this year including five (5) new \$10,000 need-based Regional Mega Scholarships to undergraduates. We will also partner with The Society for the Preservation of Greek Housing (SPGH) with up to \$40,000 in matching grants to chapter houses that qualify (see attached articles).

Our goal is to better the lives of undergraduates by providing scholastic funding to help with the financial challenges of their ever-growing college expenses. Your generous support allows us to do so.

I would like to thank our Board of Directors, past and present, for their countless hours of volunteer dedication both in terms of desire to be a positive influence in the lives of our undergrads and also for

Psi Chapter at Penn State Chosen for PKS ED Fund's First Matching Gift Program

with Society for Preservation Of Greek Housing (SPGH)

We have a very exciting announcement to share about a collaboration that is certainly a win-win-win! We are pleased to inform you that we have started a brand new tax-deductible "Foundation to Foundation Matching Grant Program" partnership between our PSI chapter, the Phi Kappa Sigma Education Fund, Inc. (PKS Ed Fund) and the Society for the Preservation of the Greek Housing (SPGH). The PKS Ed Fund has supplied well over \$1 million in scholarships and other needed assistance to our Fraternity over the past 20 years. SPGH's main goal is to help preserve the historical and architecture of historical Fraternity and Sorority houses.

NOTE: The PSI chapter SPGH Matching Gifts Program spurred them to \$25,000 more in matching funds for the Chapter! A monetary gift to the Society for the Preservation of Greek Housing is tax deductible under section 501(c)(3), 170(c)(2)(B), 2055(a), and 2522(a)(2) of the Internal Revenue Code of 1986. Contributions to the Society can only be spent on historic renovation and not social or operational functions. Here is how the process works: in order for a chapter to take advantage of the PKS ED Fund's pilot matching gift program. You send a donation directly to your local Alumni Association representative. The check shall be made out to PHI KAPPA SIGMA EDUCATIONAL FUND.

They will then forward the checks to PKS ED FUND at PO Box 508, Chestertown, MD **21620**. Once these chapter noted gifts reach a total \$10,000, the PKS ED FUND will MATCH this amount and cut a check for \$20,000 to SPGH (via Foundation to Foundation giving). SPGH will then use the funds for the approved project grants for approved chapter house renovations. This is great way for all Brothers to double up year-end giving to help your house. Again, ALL contributions are taxdeductible and you will receive a confirmation letter from the PKS ED Fund for your records.

Mitch grew up in Lincoln, ME, and followed his Brother Tom Sturgeon (Alpha Delta '83) to the University of Maine where he earned his Bachelor of Science in Chemical Engineering in 1986, and his Masters of Business Administration in 1995. Mitch was a chemical engineer and business manager in technology field, pulp and paper manufacturing, environmental engineering and water resources management before being forced to retire with full disability due to multiple sclerosis.

Today, Mitch is an author, blogger, and disability advocate. In 2018, he published his memoir, "Enjoying the Ride," which was a finalist in Maine Literary Awards. The book, which is equal parts entertaining and inspiring, provides a refreshingly candid perspective on the lives of disabled people. His compelling memoir chronicles his unexpected MS diagnosis and his courageous battle against an ever-crippling disease. He details his journey with introspection, clarity and humor. It is a testament to the amazing BROTHER he truly is.

"After I was elected Alpha at Phi Kap, I learned how to run a facility with 30 or so residents. It was so much more educational than simply living in a dormitory or apartment. Most importantly, I think, being a member of Phi Kappa Sigma taught me how to interact with my peers — to learn from them, to build relationships with them, and to lead them"

Advice for graduating Phi Kap:

"Act as if everything you work for will disappear tomorrow. My point is that you must enjoy the journey. Don't just imagine a future where you will be happy. If you're not happy on the road to that future, then you need to make adjustments in your life. Live for the day while working toward the future."

Who or what shaped me:

"As a disability advocate, I was most influenced by my mother, who was a quadriplegic since I was 5 years old. To me, she was just like anybody else's mother—she took care of me. She just did it from a wheelchair. I had no idea that the lessons she would teach me would be so relevant later in my life."

Alpha Upsilon Changes Annual Golf Outing name to the "Gary R. Stone Memorial Scramble"




The late Gary R. Stone, University of Washington, Alpha Upsilon '61
