PAYMENT DUE WITHIN 10 DAYS OF RECEIPT OF STATEMENT

Subject to applicable law or regulation, Inyo Crude, Inc. may at any time, without notice, cause or liability to Customer's obligations to Inyo Crude, Inc., reduce or cancel all credit available to Customer, refuse to make any further sales, and revoke the Cardlock Membership Card upon Inyo Crude, Inc.'s demand.

Should any legal action become necessary to effect the collection of any credit extended, Renner Petroleum shall be entitled with respect to any such legal action to reasonable attorney's fees and costs, in addition to any other relief to which Inyo Crude, Inc. may be entitled. Venue for purpose of the enforcement of any obligations incurred as aforesaid shall be in Inyo County, California.

FEES: Cardlock membership cards that have past due balances are subject to the following per account fees:

- 1) Membership Hold (invalidation) \$25.00
- 2) Non-Sufficient Funds \$35.00

Cardlock membership cards that have been lost or stolen, requiring immediate lockout, are subject to the following per card fee:
Inyo Crude – Pacific Pride Cardlock System (local network immediate)
After business hours, weekends, & holidays \$25.00

IT IS THE CARDLOCK HOLDER'S RESPONSIBILITY TO IMMEDIATELY NOTIFY INYO CRUDE, INC AT (760) 873-4095 OF ANY LOST OR STOLEN CARDS.

CREDIT INVESTIGATION: I/We state the above information is true and accurate. This account shall not be effective until you approve my credit application. You may investigate my credit record and a consumer report may be requested in connection with this application.

By signing below, the undersigned hereby agrees to make themselves aware of the proper procedures for use of the automated fuel dispensing facility and will instruct all authorized users on its account in the proper and safe use of facilities, including observance of all safety procedures, use of safety devices and compliance with regulations. The undersigned shall indemnify and hold harmless from and against any claims and costs including bodily injury and property damage which arise from the acts or omissions of the undersigned and by acts of those authorized to use this account by the undersigned.

- The customer acknowledges the process of issuing access fueling network cards is a process separate and distinct from the process of issuing credit to a Customer.
- The Customer accepts total liability for all spills incurred in the fueling use of the Cardlock membership card. Card user must attend nozzle during fueling.
- Smoking is not permitted on Inyo Crude, Inc. premises or the premises of any access fueling site.
