#### CHANGES TO THE GW PARKWAY

With the Safety Improvement Study of the GW Parkway concluded, the National Park Service (NPS) announced it will begin to implement changes in the fall of 2021. Its intent is to make the road safer for drivers, cyclists and pedestrians. You can access the study at: https://www.nps.gov/gwmp/learn/management/south-parkway-safety-study.htm

The initial steps include:

- Re-striping the roadway to implement a "road diet" while maintaining driving capacity; road markings between Tulane Drive and Stratford Lane will be changed to reduce travel lanes to two northbound and one southbound, with the remaining lane as a turn lane.
- Increasing visibility of lane markings.
- Removing vegetation at intersections to improve visibility.

Future work will install traffic circles(roundabouts) at all intersections from the Alexandria border to Stratford Lane. NPS will also continue to implement safety solutions through education, enforcement, and engineering approaches.

The intended changes have not received universal support from Mount Vernon District residents. Some predict drivers will divert to other roadways, e.g. Fort Hunt Road. Your opinions on the proposed change are important, and comments and criticisms can be directed to our local federal and state lawmakers.

#### AIRPLANE NOISE. ITS BACK.

As airplane traffic returns to its pre-pandemic level, noise will again impact HHV. The Metropolitan Washington Airports Authority (MWAA) Community Working Group (CWG) continues to advocate for departure paths that would decrease noise in HHV and neighboring communities. The FAA continues to study the noise problem, an activity interrupted by the pandemic and discovery that the data used was outdated. The CWG is seeking outside help to work on its behalf.
