RESTORING PAUL SPRING

At our November 2019 meeting, Fairfax County's Stormwater Planning Dept. briefed a preliminary plan to re-work the Paul Springs floodplain from Mason Hill to Collingwood Road. They cited severe stream bed erosion as the reason. The briefer also noted that due to the use of large machines, large swaths of trees and vegetation would be removed, but the end product would naturalize within two or three years. A similar project is now underway in Hollin Hills. Reports indicate it has caused

community pushback due to the extensive vegetation removal.

County staff briefed the MVCCA Environment Cmte. in January, and Dorothy Keough, HHVCA's Environment Chair, reports that the project is in the design phase. This is the time to make sure the neighborhood's interests are reflected in the final design.

Dorothy has agreed to monitor the project and represent our interests to the County. ■

TRANSPORTATION PROJECTS

Several roadway projects are on the drawing board or under study that could have an effect on our daily routes and routines. These include:

- (1) large-scale upgrades to Richmond Highway as it transforms to a multimodal transportation zone;
- (2) traffic flow and pedestrian safety improvements at the intersection of Richmond Highway and Fort Hunt Road;
- (3) a safety improvement study of the GW Parkway.

These efforts involve different groups often with different priorities. Citizen groups like ours, business interest, politicians and local/state/federal agencies all share a role in developing a plan and seeing it completed.

Our involvement in the process takes place through the MVCCA, and its Transportation Cmte. As a member of MVCCA's group, our Transportation Chair, Gary Drane, is involved in the process.

Several info sources are available to keep you up-to-date. An excellent overview of the Richmond

Highway Revitalization Plan can be found in Alexandria Living magazine's November 2020 issue (<https://alexandrialivingmagazine.com/news/north-gateway-area-of-richmond-highway-moves-one-step-closer/>).

VDOT details its Route 1 plan at: virginiadot.org/projects/northernvirgia/richmondhighway. Fairfax County plans fall under several offices. Search its site (fairfaxcounty.org) under EMBARK for a list of County's plans and actions.

Up-to-date info on Ft Hunt/Richmond Highway intersection can be found at MVCCA's site (MVCCA.org). The Committee's Nov. 9, 2020, meeting minutes document its advocacy for improvements to visibility, crosswalk markings, and fixing confusing routes at the site. Fairfax County staff has produced a report on the subject, but it appears that VDOT is not on board yet.

As for the GW Parkway study, the National Park Service is behind schedule on releasing its report and website info is out of date. ■

NEIGHBORHOOD WATCH WALKERS

A community with a working Neighborhood Watch (NW) program is a cost effective crime prevention technique. Its basic elements are cooperation, education, and constant update.

Passive observation can be a big help. Neighbors who are home during the day or walk the neighborhood can help the effort.

Our NW Team is asking for neighbors to be Neighborhood Watch Walkers, i.e. crime-fighting by simply walking around. Those out for a leisurely stroll, a fitness walk, or a dutiful dog walk can provide eyes on "unusual" activity, or even thwart a planned event.

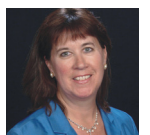

Hollin Hall News and quarterly meetings went on hiatus last March with the expectation we would be back in July. We are now nearly a year past, and the health crisis has not slowed. Through the pause, HHVCA continued to track issues and events, participate virtually in larger community forums, and communicate items of interest through emails to those on our list.
