PAUL SPRING STREAM RENOVATION

In November 2019, County staff briefed us on its plan to renovate and restore Paul Spring stream from Mason Hill to Collingwood Road. The project is in the design phase and as a result of issues raised by our Hollindale neighbors - extreme stream bank erosion along their properties - Supervisor Storck formed a Citizens Advisory Group to partner with County staff in final plan development. Our Environment Committee Chair, Dorothy Keough, is a member of this group, and is leading HHVCA's interaction with the County Staff and neighboring communities.

As the project approaches its final design phase, it is important that HHV establish what it wants to see in the project and work to include it in the final plan. Dorothy has done some deep digging on the preliminary design, and provided comments to the County on the project's environmental and construction impacts. We have also suggested transforming the stream valley into a more park-like setting.


We received several great ideas. If you would like to contribute to CAS projects, please contact us.

Yard Waste Collection

Broken limbs and branches and leaves in large paper bags started showing up on HHV curbs soon after our early January snowstorm. But the yard waste wasn't picked up following Monday, or the Monday after, or weeks following. What happened?

As is turns out, the County only collects yard waste on our normal Monday schedule between March 1 and December 24. During that time, put yard waste in County issued trash carts.

Here's a brief summary of the County's yard waste guidelines:

- Yard waste is organic waste generated by yard and lawn care to include leaves, grass trimmings, shrubs and tree trimmings.
- Soil, mulch, sod, stumps, whole trees, large branches or limbs or clean-up from storm damage will NOT be collected.
 - must be placed at the curb separately from trash and recycling.
 - must be placed in compostable paper bags/rigid containers. [No plastic bags.
 - small quantities should be tied in bundles weighing no more than 50 pounds; pieces should be no longer than 4 feet in length and 6 inches in diameter.
- More than 4 bundles should be scheduled for a Special Pickup. A "special pick-up" option is available all year long and can be scheduled through the website. Each household is limited to no more than 4 pick-ups per year.

There are other rules about waste collection in the County. Please visit the County's Recycling and Trash Customers webpage. ERADICATING INVASIVES



Our neighborhood and surrounding areas have seen a dramatic decline in tree canopy due to various reasons, but a big cause is competition from invasive species. Vines like English Ivy, Porcelain Berry, Asian Wisteria, and Japanese Honeysuckle smother and strangle trees.

The Friends of Dyke Marsh have approached HHVCA with an offer to train HHV residents on the identification and removal of invasive species in our neighborhood. The training will take less than an hour to complete. Contact us through the website if you are interested in the training. 2022 Real Estate Assessments

The 2022 real estate assessment notices were mailed last month. Based on market-driven values, countywide residential real estate assessments are up an average of 9.57% this time around and nearly 20% since 2020. In 2021, residential housing prices increased in most areas due to low interest rates, low inventory and high demand. Retail, apartment, hotel and industrial properties also increased in value, but high-rise offices declined in value as remote work continues.

The estimated tax levy shown on your assessment notice is only an estimate and your actual tax payment will depend on the tax rate established by the Board of Supervisors during the budget process now underway. The tax is derived from a combination of the 2022 assessment and the tax rate established during the budget process.
