Financial Report – Presented by Dianna Lindhag – Treasurer. All present members reviewed the Financial Report as written. Dianna stated there are thousands of in-kind donations that do not hit our budget. It is a very bare budget. Dianna explained the budget columns.

Eileen Dubowski - Question regarding Adopt a family, do funds go into the designated account? Yes, these do go into a designated checking account. Anything that goes into savings or designated we do not pay the 10% benevolence on. Motion to accept the 2023 Financials by Janis Robertson. Seconded by Jo Schackman. All in favor – motion passed.

Approval of the 2025 Budget proposed/presented to Congregation: Dianna Lindhag - This budget is what we have done in the past/recently and this is what we are going to propose. We came up with a Vision Growth fund to work towards having a full-time pastor in the future. These are for funds set aside for when we are ready to call a full-time pastor. \$8,800 is the 10% of the benevolence owed to the Alaska Synod, based on projected operating.

Pastoral – Part time pastor salary: ELCA Gives us a guideline and it is adjusted for living in our area. Contract started July 1, 2023. We give him the annual raise on July 1 (1/2 of 2024 and ½ of 2025). IRIS allows them to pay part of the salary

as housing allowance, which is not taxed. Other ½ of SECA is reimbursed to Pastor. \$41,531 per year. Program – includes the Vision/Growth. Admin/General. Significant increase to Insurance from \$6000 to 9000. Payroll/Expenses

Discussion - Eileen Dubowski - What are dues and Subscriptions \$2,000? CCLI - Music Subscriptions to stay legal - Copyright. Eileen Dubowski - There is nothing on here as a supply pastor. This is correct - we typically pay about \$100.00 and typically not more than \$500/year. Evan Keil - Where are the cell phone and computer expenses listed? They are listed under utilities. Eileen Dubowski - Is the supply pastor under professional services - \$500.00? Under professional services the piano tuner is in there. I would need to confirm. Sam Aleshire - we did not have Supply pastoral expenditures in 2024, in 2023 we did have a supply pastor expenditures. Brenda Sadler - Are we seeing a savings for changing over to natural gas? Dianna - it is not more - \$5966 as of November, last year \$7,900.

Dianna – Needs to know if we want to carry on with the 4 local charities, do you want to reduce, increase? Jo Schackman – Consider 2 charities and giving each \$1,000K then rotate. Jo Small – Motion to donate \$1,000 to 2 charities the first year and alternate to the other 2 the second year. Romouna Sandbo – Would like to keep it the 4 charities as they all benefit. Eileen Dubowski – Amend the motion to select two charities, to give \$1,000 and decide what we want to do next year. Motion failed.

Motion - Continue the pattern of 4 charities (Fairbanks Rescue Mission, The Door, Helping Alaska, Fairbanks Foodbank) \$500.00 each by Margi Ungrodt. Seconded by Ramouna Sandbo. Motion passed

Motion to pass the budget as is made by Curt Renner. Motion to utilize a portion of our growth and vision fund give an additional \$200.00 to each of the 4 charities a total of \$700.00/total \$2,800 by Evan Keil. Seconded by Eric Peterson. Motion passed.

Office Manager's Report

It's been a good year for Lord of Life! I'd like to provide an update on two programs begun last year.

The **Little Free Library** is bursting with books, and many thanks to everyone who has donated. The stand didn't survive the winter very well and had to be repaired. The library should be used more, and we welcome suggestions for that.

Harvest Hosts ran very smoothly. Our first RVers arrived in April and the last ones in September. There were 59 stay requests and 1500+ page views. We've been "favorited" 42 times. Our review rating is 4.84/5 stars. Many reviewers noted how peaceful and beautiful the property is. The only negative mentioned was traffic noise, which we can do nothing about. Donations were in excess of \$1200, more than double what we received last year.

We still have a great deal of **firewood** on site, meant to be donated to families in need through Helping Alaska (fka Love Inc.), now closed. Christ Lutheran Church in Fairbanks recently asked what we intend to do with our wood, as they, too, donated wood through Helping Alaska and have wood on site (they are donating it through a local agency). Our options: sell it, work with an agency, or evaluate families for need ourselves. Council decided that working with another agency was the best option and they are following up with the Salvation Army.

In preparation for the 50th anniversary, it was agreed to buy a much-needed rolling rack to store folding chairs and sell 8 of the old, heavy 8' tables. These two simple things will help reduce clutter.

Finally, although hired for 20 hours per week, my workload hasn't supported that since the pandemic. Most weeks I work 10-15 hours and take Fridays off, except during the Lent/Easter and Advent/Christmas seasons. Since I am an hourly employee, this has saved on payroll.

It's a privilege to work here (7 years now)!
