# **BORREGO DAYS DESERT FESTIVAL POLICIES**

- All booths must be open during the Open days and hours of the event. The Open days and hours are: Saturday, October 21 10:00 AM - 5:00 PM Sunday, October 22 10:00 AM - 5:00 PM
- 2. Check in and setup Friday, October 23 between 10:00 AM and 4:00 PM; Setup only (**must check in Friday**) Saturday, October 21 between 6:00 AM and 8:00 AM. **DO NOT drive on the grass!**
- 3. Times listed for setup of your booth are the maximum windows of time available, and, unfortunately, are not flexible.
- 4. Soroptimist, Borrego Springs Chamber of Commerce and McFarlane Promotions are not responsible for closure of your booth by San Diego County officials, including inadequate health or fire equipment standards.
- 5. Your booth should be totally self-contained for each day. Please plan ahead. Since vehicle access is limited, it is important to estimate the number of items you will be selling. You are responsible for keeping and leaving your booth area clean and safe, and securing all signs. Bring your own trash cans for the inside of your booth. Trash containers within Christmas Circle Park are for the festival attendees. Please dispose of your booth trash at the dumpsters across the street from the Park.
- 6. You agree to sell only such items on your preapproved list included with your application, and agreed to by the Soroptimist. No provision of the preapproved list shall be modified unless in writing signed by an authorized representative of Soroptimist.

# **BOOTH REQUIREMENTS**

#### **Soroptimist Provides:**

- > 10' x 10' space NO EXCEPTIONS!
- Electricity: If electricity is required, prior arrangement must be made with Soroptimist; it will be an additional \$50.00 fee; it may be in limited supply so order early; and, food vendors have priority.

### All Vendors are Required to Have:

- Self-Contained Booth
- Seller's Permit
- Licensed Driver and Proof of Insurance for any vehicle driving on public roadways.
- Certificate of Insurance to County of San Diego specifications if required by County of San Diego.
