

BORREGO DAYS

Waiver and Release

MUST BE SUBMITTED PRIOR TO BORREGO DAYS PARTICIPATION

Each participant must sign this Waiver and Release to participate in Borrego Days, and if under 18 years of age parent or guardian must sign.

In consideration of the acceptance of my/my child's participation in Borrego Days, a festival and parade, ("Borrego Days"), I, the undersigned participant/participant's parent or guardian, do hereby for myself/my child forever waive, release and discharge any and all rights, claims and actions for damages that I/my child may hereafter accrue against any and all persons, organizations and entities associated with Borrego Days, including, but not limited to, the Borrego Springs Chamber of Commerce, Borrego Festivals Foundation, Borrego Springs Fire Protection District, Borrego Springs Performing Arts Center, The Center, Christmas Circle Community Park, and The Mall, each of Borrego Springs, and McFarlane Promotions of San Diego, and each's owners, representatives, employees, agents, heirs and assigns, arising out of or in connection with my/my child's entry in, travel to, participation in, and return from Borrego Days. I attest and verify that I am/my child is fully able to participate in Borrego Days. I understand that special accommodations cannot be made for injury, bodily harm and/or property damage.

Further, I hereby grant to the Borrego Springs Chamber of Commerce, the Borrego Festivals Foundation, and McFarlane Promotions, and their representatives, employees, agents and assigns, the irrevocable and unrestricted right to use, reproduce and publish photographs, video and audio recordings of me/my child, including my/my child's image and likeness depicted therein, for editorial, trade, advertising or any other purpose and in any manner or medium; to alter the same without restriction; and to copyright the same. I hereby release and hold harmless all persons, organizations and entities associated with Borrego Days, including, but not limited to the Borrego Springs Chamber of Commerce, the Borrego Festivals Foundation, and McFarlane Promotions, and each's representatives, employees, agents and assigns, from any and all claims, actions and liability relating to the use of said images and likenesses.

It is the responsibility of Band Directors to be in possession of a Borrego Days Waiver and Release for each minor participant in their charge signed by each minor participant's parent or guardian prior to departure from point of origin. All other Borrego Days participants are to have turned in their completed Borrego Days Waiver and Release prior to their participation in Borrego Days.
