For all clients:

All payment is due upfront at time of reservation. We accept cash/check/Venmo/Zelle Credit card option coming soon.

All dog behavior/training clients must list the current veterinarian's number in order for Devoted 2 Dogs to contact and consult regarding your dog's health.

Dogs must be current for Rabies, DHLLP (distemper) and Bordetella (kennel cough). Cats must be current for Rabies.

Please make sure your dogs are up to date on flea and tick treatment.

Please bring current vaccination records on first appointment.

No service(s) guarantee a result. No service is refundable.

Prices and discounts are subject to change without notice. Changes will be posted here immediately.

Payment Policy:

All payment is due upfront at time of reservation.

Cancellation Policy:

All cancelled appointments are automatically charged.

Dog Training and Behavioral Rehabilitation clients:

Packages must be completed within 6 months of purchase.

Group Classes clients:

You must join us every week for class. If you miss a class, you can not make it up and you will miss part of the curriculum. By paying your tuition you are reserving your dog's place for 6 weeks.

Dog Walking and Walk and Train clients:

2 walks per week are required in order to hold a timeslot.

Agreement to Hold Harmless and Assumption of Risk

I hereby release Devoted 2 Dogs, its employees, owners, directors, representatives, subcontractors, agents, animal owners, customers and potential customers from any and all liabilities, financial and otherwise, for injuries to myself, my dog, or any other property of mine, which arise in any way at any time directly or indirectly from services and/or products provided by or as consequence of my association with Devoted 2 Dogs.

I agree to assume all liabilities and responsibilities, financial and otherwise, for the behavior and health of my dog. In consideration of the services rendered by Devoted 2 Dogs, I hereby waive any and all claims, actions or demands of any nature foreseen or unforeseen, including without limitation any claims relating to the care, control, health, and/or safety of my dog, claims arising during training, pick-up or drop-off of my dog, and/or any boarding services for my dog, relating to, resulting from or arising out of my involvement with or participation in any activity of Devoted 2 Dogs that I may have

against Devoted 2 Dogs, its employees, owners, directors, representatives, subcontractors, agents (collectively, the "Releasees").

I hereby agree to indemnify, defend and hold harmless the Releasees from and against any and all claims, damages, injuries, losses, liabilities, expenses, or injuries arising directly or indirectly as a result of any action by my dog or any other dog including any claims by myself, my family members or any other person accompanying me to or present with me at any function, program, event or activity of Devoted 2 Dogs.

I authorize Devoted 2 Dogs to do whatever they deem necessary for the safety, health, and well-being of my dog while under the care of Devoted 2 Dogs, including seeking professional veterinary treatment for my dog as deemed reasonably necessary by Devoted 2 Dogs in its sole and absolute discretion.

THIS IS A COMPREHENSIVE LIMITATION OF LIABILITY AND IN NO EVENT SHALL DEVOTED 2 DOGS OR ANY OF THE RELEASEES BE LIABLE, JOINTLY OR SEVERALLY, TO ME OR ANY OTHER PERSON AS A RESULT OF OR IN CONNECTION WITH THE SERVICES OFFERED TO ME BY DEVOTED 2 DOGS, INCLUDING, WITHOUT LIMITATION, FOR INDIRECT, CONSEQUENTIAL, SPECIAL, INCIDENTAL, PUNITIVE, OR EXEMPLARY DAMAGES, LOST PROFITS, LOST SAVINGS, AND LOST REVENUES, OR OTHER PECUNIARY LOSS (COLLECTIVELY, THE "EXCLUDED DAMAGES"), WHETHER OR NOT CHARACTERIZED IN NEGLIGENCE, TORT, CONTRACT, OR ANY OTHER THEORY OF LIABILITY, EVEN IF DEVOTED 2 DOGS OR THE RELEASEES HAVE BEEN ADVISED OF THE POSSIBILITY OF OR COULD HAVE FORESEEN ANY OF THE EXCLUDED DAMAGES, AND IRRESPECTIVE OF ANY FAILURE OF AN ESSENTIAL PURPOSE OF A LIMITED REMEDY. IF ANY APPLICABLE

AUTHORITY HOLDS ANY PORTION OF THIS SECTION TO BE
UNENFORCEABLE, THEN THE LIABILITY OF DEVOTED 2 DOGS WILL BE
LIMITED TO THE FULLEST POSSIBLE EXTENT PERMITTED BY APPLICABLE
LAW. WITHOUT LIMITING THE FOREGOING, UNDER NO CIRCUMSTANCES
SHALL DEVOTED 2 DOGS BE LIABLE FOR ANY CLAIM, LOSS, COST,
EXPENSE, OR DAMAGE WHATSOEVER TO ME OR ANY THIRD PARTY IN AN
AMOUNT EXCEEDING THE SUM ACTUALLY PAID BY ME TO DEVOTED 2
DOGS DOG DURING THE TWELVE-MONTH PERIOD IMMEDIATELY
PRECEDING THE DATE ON WHICH DEVOTED 2 DOGS IS NOTIFIED OF SUCH
CLAIM IN WRITING.

Due to the many outstanding benefits of dog socialization and Devoted 2 Dogs commitment to the safety and well-being of my dog, I agree that the benefits of dog socialization outweigh the risks.

I understand that Devoted 2 Dogs has the right to refuse service to me and/or my dog at any time for any reason. I understand that if my dog has a history of or repeatedly demonstrates aggression or biting of humans or animals, Devoted 2 Dogs reserves the right to refuse service. I understand that all bites may be reported to the local authorities to the extent required by law.

I hereby declare to Devoted 2 Dogs that I am the legal owner of my dog; that my dog has not been exposed to distemper, rabies or parvovirus within the past thirty (30) days, that my dog has been inoculated as indicated by records presented.
