## Herb Sauermann Appointed To Post Vacated by Shonk

Herb Sauermann, Omega Deuteron '49, has taken over as local chapter adviser this semester, after Al Shonk was appointed District Governor. Al served four and one half years in the adviser

Herb is a native of Huntington Park, California, born there April 10, 1926. After graduating from high school in 1943, he enrolled in the Army Reserve Training Program and was called to active duty in April, 1944, seeing combat service until his discharge in 1946.

In September of that year he entered the University of Southern California where he was pledged by Omega Deuteron. He became quite active in fraternity affairs, both as a pledge and as an initiate of that chapter, holding a number of offices and committee chairman assignments. He also represented Omega Deuteron on the IFC at Southern California.

His ability as an organizer was recognized in many extra-curricular activities in which he participated, such as the Student Council, athletic team managerships and also on the Varsity Debate Team. He admits having been in university politics with both feet.

In February 1949, Herb left the University to return to active duty as a Second Lieutenant in the Infantry. Again he showed he has what it takes, when he rose to the rank of Captain. As Aide-de-Camp to two Generals, he obtained invaluable experience in organizing and planning projects, lecturing and supervising the many details demanded of an infantry officer. He 

returned to civilian life in October 1955.

Herb was a Field Secretary for Phi Sigma Kappa from September 25, 1956, to August 1, 1957. He worked on expansion leads and made chapter inspections in the Eastern part of the United States. He helped Secretary-Treasurer Herbert L. Brown move the national headquarters from Chicago to Drexel Hill, Pennsylvania.

Following his service to Phi Sigma Kappa, he moved to New York and completed work on his degree at Columbia University.

He moved back to Southern California in 1960 and is currently teaching eighth grade at Whittier Christian School, a Baptist School, and coaching football. Herb is working towards his Master's Degree evenings at Los Angeles State College.
