### More on the Budget & Expenses for 2025

As we step into the vibrant fall and winter season, we want to take a moment to share some updates regarding our HOA and the financial stewardship of our community. For an incredible 18 years, we've been able to maintain our dues without any increases—a reflection of the Board's commitment to careful budgeting and cost management.

However, as many of us are aware, the cost of inflation has been impacting the Association, just as it has our own households. Maintaining our community's programs and common areas have been steadily rising. While the Board has worked hard to absorb these increases, we've reached a point where a few adjustments are necessary to ensure we continue providing the quality services and maintenance that make our neighborhood special.

To proactively address this challenge while avoiding an increase in annual dues, the Board has approved modest increases in two specific areas:

- •The closing document fee has been adjusted from \$100 to \$150.
- •The **new resident start-up fee** has increased from \$250 to \$350.

We appreciate your ongoing support as we work together to keep our costs down, 18 years is pretty remarkable.

## **Increased Fines for Repeat Offenses**

To protect the safety and integrity of our community, the Board, in collaboration with the village and our legal team, is addressing recurring violations of HOA rules. Examples include blocking sidewalks with vehicles and parking trailers in driveways—issues that pose risks and disrupt community standards. This past Halloween, children were forced into the street in several areas due to blocked sidewalks, highlighting the urgency of these concerns. To deter repeat offenses, we are increasing fines for such violations. Your cooperation is essential to keeping our neighborhood safe and welcoming for everyone.
