Update on Front Entrance

Charley

Update/Discuss Invoices for Dues

Motion made to mail out invoices in early December with due date in early January. Dues will be \$180 per household for 2025. Motion by Scott M., Second by Eric L. Passed 3-0.

Review Budget for 2025

The budget is becoming strained. The Board has elected to increase two fees to try and offset the increases in expenses. We will be raising the Capital Contribution Fee for new residents from 250 to 350. The seller's TECA Paid Assessment Letter fee will be increased from 100 to 150. The Board will revisit the expenses mid-year in 2025 to see if these changes are sufficient. The motion was made by Eric L., seconded by Scott Mueller, and passed 3-0.

Budget was presented and voted on for 2025 including Capital Expenses. This reflects the anticipated new revenue of 5000 dollars from the above fees. Motion was presented by Charley G., seconded by Scott M, and the motion passed 3-0.

Update on Sprinklers/shutdown

The Sprinkler shutdown went fine for Fall 2024. We will have several sprinkler heads replaced in the Spring. We will reflect this in the budget for 2025

New Business ALL

Motion to pay bills that are budgeted

A motion was made to allow the Treasurer to pay bills that fall within the budget without holding a board meeting. Motion was made by Eric L, seconded by Scott M., and passed 3-0

Increased Fines for Repeat Offenses

To protect the safety and integrity of our community, the Board, in collaboration with the village and our legal team, is addressing recurring violations of HOA rules. Examples include blocking sidewalks with vehicles and parking trailers in driveways—issues that pose risks and disrupt community standards. This past Halloween, children were forced into the street in several areas due to blocked sidewalks, highlighting the urgency of these concerns. To deter repeat offenses, we are increasing fines for such violations. The Board will advise of progress on this matter.
