### **Yard Projects - Fences**

Proper Preparation saves time and frustration – Fences

The question always comes up, what do I have to do in order to install a fence in my yard? Please see section 7.09 in Covenants. First, you need to pull a permit from the Village of Plainfield. The Village has guidelines that must be maintained. Second, you have to get approval from the TECA Board of Directors. This is easy, simply send your drawing and project details to our email:

What happens if these are not followed? If a fence is found to be in violation it may have to be removed or fitted to comply. Our goal is to ensure all projects meet the covenant requirements

## **Q&A on Swimming Pools**

## What are the rules for swimming pools within TECA?

Pools must be in-ground or may not be any higher than 2 feet above ground (partially inground). See Page 11 7.04 in Covenants.

## We see a lot of blue inflatable pools, are these allowed?

These pools were not available when the Codes and Covenants were written, so they were not formally addressed. At this time, The Board has decided to allow them as they are not permanent structure pools. This means that they must be taken down every Fall and stored. Portable pools may be set up no earlier than May 15<sup>th</sup>, and must be taken down no later than October 1<sup>st</sup>. Pools that are erected outside of this window shall be considered permanent and could be in violation.

#### Do we have to fence our pool?

The Village of Plainfield has rules and regulations on fence heights as well as proximity when it pertains to pools. Please check with the Village on pool/fence requirements.

## Do we have to get approval from Village and TECA for a pool?

Yes. Pools that are installed without approval/permits are subject to removal with all costs being charged to the owner.

# We are interested in installing a pool, are there any residents who have pools we could talk to?

Yes. The Board has several residents who have gone through the process and are happy to share their insights, please email us for more information.

### **Q&A** on Pets

#### The Board's Position on Pets

The Board defers to the Village of Plainfield on rules and ordinances regarding pets. On occasion the Board will act on our residents behalf in order to advise or alert residents to a potential issue in lieu of the Village taking action.

#### Are we required to have our pet on a leash?

Yes. The Village of Plainfield requires this.

# Does the Village have an ordinance regarding excessive barking?

Yes. If you have a neighbor whose pet is barking excessively, we encourage you to reach out to the neighbor first before calling the Village.

#### Where can we find more information?

# Can the Village issue citations and or fines regarding pets?

Yes. It is our hope that this will not happen and that our neighbors can communicate with each other. However, the Village does reserve the right to issue citations and or fines.

#### Can pets run through "Invisible Fences"

Yes. If you an invisible fence, please remember that if your pet sees a rabbit or other animal, they can run through the invisible fence line. Also other animals, kids, etc, can always enter a yard with an invisible fence. Please remember to keep an eye on your pets if you are using an invisible fence.
