STATE PRIMARY, STATE GENERAL AND COUNTY GENERAL
THURSDAY, AUGUST 1, 2024**

A Democratic and Republican State Primary, a State General Election and a County General Election are hereby called for in Trousdale County, TN for Thursday, August 1, 2024, between the hours of 7:00 am and 7:00 pm at all the precincts to elect the following:

STATE PRIMARY ELECTION

US Senate (6 year term)
US House of Representatives (6th Congressional District) (2 year term)
TN House of Representatives (35th District) (2 year term)
TN Senate (18th District) (4 year term)
Democratic Executive Committeeman (representing the 18th TN State Senatorial District) (2 years to fill an unexpired term)
Democratic Executive Committeewoman (representing the 18th TN State Senatorial District) (2 years to fill an unexpired term)

STATE GENERAL ELECTION

Tennessee Supreme Court state wide (retention election)
Tennessee Court of Criminal Appeals-Western Division state wide (retention election)

THE QUALIFYING DEADLINE IS THURSDAY, APRIL 4, 2024, AT 12:00 NOON.

Candidates for statewide office must file their nominating petition with the Tennessee State Coordinator of Elections in Nashville no later than 12:00 noon, Thursday, April 4, 2024.

Other Primary Candidates must file their original nominating petition with the County Election Commission in which he/she is a resident and shall file a certified duplicate of the nominating petition with the County Election Commissions in all counties wholly or partially within the area served by the office which the candidates seek.

Independent Candidates to be on the November 5, 2024 General Election ballot must file their original nominating petition with the County Election Commission in the county in which he/she is a resident and shall file a certified duplicate of the nominating petition with the County Election Commissions in all counties wholly or partially within the area served by the office which the candidates seeks by 12:00 noon Thursday, April 4, 2024. Withdrawal deadline for all candidates is Thursday 12:00 noon, April 11, 2024. Withdrawal statements must be in writing and signed by the candidate.

COUNTY GENERAL ELECTION

Assessor of Property (4 year term)
Superintendent of Roads (4 year term)
School Board Member- District A (1st&2nd County Commission Districts) (4 year term)
School Board Member- District C (5th&6th County Commission Districts) (4 year term)

Any qualified voter desiring to be a candidate for the school board offices must obtain a nominating petition from the Trousdale County Election Commission. The deadline to file a petition was in December 2023 for candidates for Assessor of Property and Superintendent of Roads to accommodate the March local primary. Candidates for School Board must be a resident of the county for a period of at least three (3) years before the deadline for filing as a candidate, be at least 21 years of age and be a high school graduate or equivalent. The deadline to file nominating petitions and all supporting documents (if required) is **12:00 noon Thursday, April 4, 2024**. Withdrawal deadline for all candidates is Thursday 12:00 noon, April 11, 2024. Withdrawal statements must be in writing and signed by the candidate.

The last day to register to vote for the August 1st election is July 2nd, 2024. You may register to vote at the Trousdale County Election Commission, Tennessee Department of Motor Vehicle Driver Testing Centers,

Tennessee Department of Human Services Offices, the Trousdale County Health Department, or any other public assistance agency. Voters who register at the above locations will be considered “in-person” registrations. You may also pick up by-mail registration forms at the office of Register of Deeds, the office of County Clerk, the TCHS library and the Public Library. Voters who register “by-mail” are required to vote in person the first time they vote. Voters who are already registered in Trousdale County may update their address or name by visiting the Election Commission Office, by sending in their voter registration card with corrections, by sending a written request over their signature or during early voting. Voters who fail to make changes prior to Election Day may experience a delay in voting. Federal or Tennessee government issued photo ID is required to vote, unless an exception applies. College student IDs will not be accepted. To learn more about the law and its exceptions, please call 615-374-2712 or visit GoVoteTN.com. The Election Commission Office is located at 214 Broadway, Hartsville, Tennessee. Regular Office hours are 7:30am to 4:30 pm, Monday through Friday. The office will be closed on county holidays.
