Highlights of Session

- Loss of Parent's Rights: SB172 – Family Resource Centers inside schools can dispense birth control, HPV vaccines (no longer medically recommended!), preventative HIV medication. **All without parental consent.**



Parent's Rights Laws

- SB163 – Gender reassignment services/surgery now funded through government mandate to be covered by (taxes) medicaid and also private pay insurance.
- SB131 – Sex Trafficking / Abortion for Minors. Illegal! This new law defies Section 2, Article 4, the Governors extradition clause power of the US Constitution.
 - Example: Idaho cannot require that their resident be arrested if found in NV, bringing a minor here for an abortion.
 - Protects predators (child sex trafficker PIMPS) and only facilitates a greater degree of human sex trafficking.



Medical Patient Rights

- SB149 and AB7 – All medical information for Nevada patients will be stored in a federal database (not a local hospital or a local doctor's office computer system). This database is currently shared with the World Health Organization.
- As a patient you can request your data be removed from the national database and that a document be provided to you and kept on file at the practice as a permanent record of your decision.



Medical Patient Rights

- SB109- Organ harvesting, green lighted. No longer is prior permission required from patients during a hospital stay to obtain an “anatomical gift” to be harvested. Sponsored by Dem Rochelle Nguyen of Las Vegas.

Medical Patient Rights

- AB354- Prohibits guns within 100 feet of a polling location. Unconstitutional, polling sites are in inside malls and grocery stores etc.
- AB355- Prohibits those under the age of 21 from purchasing a firearm. One opponent argument is that this same of rule should be applied for entry into the armed forces. It would reason then that the age should now be 21 for entry.
- SB171- Hate Crime Firearm Law. Makes certain gun violations with additional penalties The criteria for judging what is a hate crime is unfair and completely subjective.



Voter Rights and 2nd Amendment

These items are returning to their respective subcommittees for further work before being reintroduced into the next 2025 session.

- **AJR – Voters' Rights:** A state constitutional amendment which forces NV electors to vote for the presidential candidate who won the popular vote in the state. This defies the US constitutional authors which designed the electoral college as a protection for the unregulated power that a populated state can have over the rest of the states. Defeated BDRs Back in Committee

- SJR7 – State constitutional amendment making abortion legal through all nine months of pregnancy.
- Both resolutions must still be passed by a vote in the 2025 session to be brought onto a future ballot.
