Public School and Library Staff Unaccountable to American Families

The trend of supplying children with sexually and age inappropriate material in county and school libraries has reached a boiling over point with American parents. The fact is, many childrens' books have hetero and LGB sexual themes, with 'instructional' text and pictures. Other childrens' books which encourage a focus on pronoun use and trans ideology are being purchased with tax payer funds, filling the shelves of the youth and young adult (teen) shelves. The trans ideology encourages rebellion against social norms represent a healthy aspect of a well functioning society for all American citizens. *Exposing children to this material* can be a cause of major confusion: overwhelming an immature mind and obscuring the innate connection a person has to their **God given anatomy**. Solution 1 ~ If you want safer materials for your children in the institutions your tax money pays for, here are some things you can do quickly.

- 1. Call and email library staff, directors, and county supervisors know you want your county and state to disconnect with the ALA immediately!
- 2. Demand that only wholesome books be purchased for school and county libraries.
- 3. Sexually inappropriate material needs to be immediately removed from schools.
- 4. This same material needs to be immediately pulled out of the children/youth areas and to not be permitted to be checked out by minors at the county public libraries.

Many States have terminated the ALA ~ Why?

- 1) Hostile position toward concerned parents
- 2) Their insistence upon curating sexually charged, salacious youth collections
- 3) Guiding their members employed at school and county libraries to purchase these collections.

The World Library Association aims to provide model policies, trainings and assistance based on "political neutrality" and "common sense" to public and school libraries. Dan Kleinman, a community library watchdog ran a website for 10 years detailing bizarre political activisim for LGB and Trans material aimed at youth in libraries. According to Kleinman, who founded The World Library Association says the organization will "offer financial assistance to parents involved in legal battles over sexually explicit content within public and school libraries."

"School policies right now recommend, basically that anything goes and that it's literally age discrimination to keep a child from any material," Kleinman said. "New policy guidance from the World Library Association is going to recommend that schools follow laws or case laws like Board of Education vs. Pico, a 1982 U.S. Supreme Court case that allows schools to remove educationally unsuitable and pervasively vulgar materials and to do so immediately. So schools now can have books that are for children that comply
