



AGREEMENT CONTRACT

PAYMENTS

The client is responsible for paying for their coaching sessions before their sessions. The coaches do not bill insurance companies. The client understands they will be charged for no-shows and late cancellations (within 24 hours). The client understands they are responsible for communicating, in advance notice of a minimum of 24 hours of a need to cancel a session.

The coach will try to help reschedule the client's session if advance notice is given.

The client understands they are responsible for making their payments for the coaching sessions and failure to comply with the Agreement will result in termination.

The client agrees to pay the coach in the amount of _____ for the performance of the Services (herein known as “the fee”)

Whereas the coach will invoice the Client on the final day of the full week after the Coach’s initial assignment and at the end of each week thereafter.

THE COACHING PROCESS

- Coaching is an ongoing relationship between a coach and a person who desires coaching (coachee). The coachee’s agenda is central to the relationship and will be worked on jointly by both coach and coachee.

-Coaching is not therapy, counseling, advice-giving, mental health care, or treatment for substance abuse. The coach is not functioning as a licensed mental health professional and coaching is not intended as a replacement for counseling, psychiatric interventions treatment for mental illness, recovery from past abuse, professional advice, financial assistance, legal counsel, or other professional services.

-Coaching is designed to address issues the person being coached would consider. As coach, I do not have the answers to your issues but am committed to working with you to explore them and help you identify how to move forward. There are no guaranteed results.

- Coaching is most effective when both parties are honest and straightforward in their communication.

-Coaching can involve brainstorming, values, clarification, the completion of writing, assignments, education, goal setting, identifying plans of action, accountability, making requests, agreements to change behavior, examining lifestyles, and questioning.

CONFIDENTIALITY

All terms and conditions of this agreement and any materials provided during the term of the Agreement must be kept confidential by the Client unless the disclosure is required according to the process of law.

- Coaching is a confidential relationship and the coach agrees to keep all information strictly confidential, except in those situations where such confidentiality would violate the law or could jeopardize the safety of the client or others. There may be occasions when something you share with me needs to be shared more widely, but we will discuss this first so that you are comfortable, and wherever possible, you will take the lead in sharing the information with others. The information provided by and to a client during coaching sessions is legally confidential with the coach. If the information is legally confidential, the coach cannot be forced to disclose the information without the client's consent or in any court of competent jurisdiction in the State of Colorado without the consent of the person to whom the testimony sought relates.

SOCIAL MEDIA POLICY

I understand that my coach does not accept personal Facebook, LinkedIn, Twitter, Instagram, and/or other friends/connection/follow requests via any social media. Any such request will be denied maintaining professional boundaries. I understand that the Company has or may have a business social media account page. I understand that there is no requirement that I "like" or "follow" this page. I understand that should I "like" or choose to "follow" the Company's business social media page others will see my name associated with "liking" or "following" that page. I understand that this applies to any comments that I post on the Company's page as well. I understand that any comments I post regarding my coaching work with my coach will be deleted as soon as possible. I agree that I will refrain from discussing, commenting, and/or asking therapeutic questions via any social media platform. I agree that if I have a coaching comment and/or question I will contact my therapist through the mode I consented to and not through social media.
