**Cycling Without Age Littleton enjoyed myriad accomplishments in 2022. Over 1,600 trishaw rides were given, an all-time high for one year. PBS Rocky Mountain, Channel 7 News, and Fox 31 News each aired feature pieces on CWAL. Little Man Ice Cream provided a grant to purchase the organization's 5th trishaw. Co-founder, Barb Lotze, received the prestigious Allen Buckingham Senior Leadership Legacy Award from the Colorado Council on Aging for her work at CWAL. Finally, a trishaw pilot provided \$13,500 in matchable donation funding and donations exceeded that amount by nearly \$4,000.**
