本公司抗体产品经先进的杂交瘤细胞 (或 CHO 细胞) 无血清悬浮培养技术表达, 避免腹水表达中宿主抗体的污染。经亲和层析纯化, 抗体纯度可达 95% 以上, 且可保持较高的抗体活性。本产品单克隆抗体 (1D3) 可特异性结合小鼠 B 细胞表面糖蛋白 CD19, 并经 PE 标记。

**注意事项:** 本试剂只适用于科研应用, 不可用于临床检测。
