Allison D. Gee of Allison Gee Fine Art Appraisals is an Accredited Senior Appraiser through the American Society of Appraisers, designated and tested in Fine Arts, and an Accredited Member through the International Society of Appraisers, designated in Fine Arts. She has served private, public and corporate clients throughout Arizona and the United States since 2001. Her practice focuses on American and European paintings, prints, works on paper and sculptures.

Ms. Gee earned a Bachelor of Arts in Humanities and a Masters of Art in Art History from Arizona State University, Tempe, Arizona. She studied both French and Italian, and her foreign language graduate examination was in Italian.
