This contract is valid under the following conditions:

At four (4) weeks of age a non-refundable deposit of \$500 is accepted to reserve your kitten. If you should decide, for any reason, not to continue with the purchase of the kitten, your \$500 deposit will not be refunded. No exceptions.

At the age of 8 weeks another payment of \$300 is required.

At 12 weeks of age another \$500 payment is required.

Balance of kitten purchase is to be paid before kitten is put in your possession.

We do accept for payment: Paypal (friends and family only) and Zelle.

You are responsible for any fees.

Bare Love guarantees the kitten to be in good health for 48 hours after delivery. It is your responsibility to take the kitten to the vet for a health check within the allotted time. If the kitten is found to be seriously medically deficient, Bare Love will take the kitten back and offer you a replacement from the next litter for shipping costs only. You must provide documentation from a licensed veterinarian as to the medical issue. Kitten must be returned within seven (7) days at buyer expense. After 48 hours the seller can no longer guarantee the kittens health except for birth defects.

Seller assumes no liability for veterinary bills after buyer takes possession of the kitten. When the Kitten leaves our home, the kitten has been vet checked multiple times and is deemed in good health. Bare Love Cattery guarantees the kitten from genetic and congenital defects up to 2 years of age. If the kitten should die or be euthanized due to genetic or congenital defect Bare Love will replace the kitten with one from the next litter for shipping costs only. ***The buyer must provide a necropsy from an impartial licensed veterinary pathologist stating the cause of death is unquestionably from a genetic or congenital birth defect.***

The kitten is sold with no breeding rights and will be altered before leaving my home. The kitten will be microchipped, dewormed and have age appropriate FVRCP and leukemia vaccinations done by our veterinarian. If you choose to have additional vaccines done before the next annual set of vaccinations, you are doing so at your own risk. Over-vaccinating can be deadly. You will receive a copy of vet records with the kitten.

The kitten is NOT guaranteed against respiratory diseases, fleas, ringworm or any nuisance diseases. Upper respiratory infections can be a common occurrence with the stress of moving from one home to another or shipping.

Under no circumstances shall this kitten be declawed or mistreated in any way. It is a cruel amputation and is not allowed. If we find the kitten has been declawed or mistreated, we will pick up the kitten without a court order and you surrender all rights to said kitten and forfeit all moneys paid.

If, for any reason, you cannot keep this kitten, we reserve the right of first refusal at no cost to Bare Love Cattery.

You acknowledge this kitten is an indoor cat and cannot live outdoors.

If the kitten of your choice turns out odd-eyed, you have the option of paying an increased charge or choosing another kitten if available or from the next litter.

We also have the option of retaining the kitten for our cattery.

It is understood that it is impossible to guarantee a completely hairless cat and hair may vary from kitten to kitten due to hormones, climate and genetics. Usually on tail, feet, ears and nose, but can also grow on other parts of the body as well.

I do not ship. Buyer is to pay all costs of courier or personal delivery. Usually around \$700. You may also choose to pick up your kitten. In that case, I will meet you at the Oklahoma City Airport or you can make arrangements to meet part way. I will drive up to 3 hours for \$200.

Any legal action which may arise under the terms of this contract will be brought to the county of Seminole, Oklahoma. The buyer (new owner) will be responsible for all expenses accrued due to litigation.
