## ST. CLAIR COUNTY ARABIAN HORSE ASSOCIATION RULES AND REGULATIONS

- 1. Open Breed classes are open to all horses.
- **2.** Alcoholic beverages will not be allowed.
- 3. Proper attire must be followed at all times, i.e. no shirt, no service.
- **4.** Dogs must be kept on a leash at all times.
- **5.** Children will be requires to be under constant supervision of parent, guardian, or other supervisor specifically appointed by the parent or guardian. Unsupervised children may be grounds for dismissal from the show.
- **6.** Illegal appliances and substances will not be allowed.
- 7. Kick Chains will be allowed in the stalls.
- **8.** Neither SCCAHA nor the Show Facility will be held responsible for any injuries or lost/stolen property.
- **9.** Horse owners shall carry own liability insurance and will assume full responsibility while at the shows.
- **10.**CURRENT-NEGATIVE COGGINS Test are required (at time of entry) current meaning within current year.
- **11.** Horse Stall Fees are \$35.00 per weekend or \$25 per day, Tack Stall Fees are \$10 per day. \$5.00 will be returned per stall that is cleaned and approved and an office fee of \$8.00 per show/ per horse.
- 12. Regular Class fee is \$6.00- Specialty Class and Sweepstakes Class fee is \$10.00
- **13.**Camping fee- \$25.00 per day/ per camper/ tent. Staying on the grounds overnight is camping.
- 14. Exhibitors must enter classes at least 2 classes prior to the class he/she will participate in.
- **15.** All horses must be serviceably sound.
- **16.** Youth shall not be allowed to show nor ride a stallion of any age.
- 17. The maximum length of the horse's toe is to be  $4\frac{1}{2}$  inches. The maximum weight of the shoe is 14oz., excluding pads and nails.
- 18. Membership includes Daily High Point at the show.
- **19.** For showing purposes, the age of the rider/handler will be tabulated as of January 1<sup>st</sup> of the current year.
- **20.** All horses must be under control at all times and maybe subjected for dismissal from the show by the President of SCCAHA.
- 21. Unruly horses will be excused from the show ring by the judge.
- **22.**Protest MUST be submitted to the SCCAHA Board of Directors, in writing, and will be deliberated on during their next appointed meeting. A \$25.00 filing fee MUST accompany each written protest. This is a NON-REFUNDABLE fee.
- 23. Chaps are optional in all Western classes.
- **24.**Headers, may be used at the final line-up (for safety purposes) in Walk-Trot classes. Headers are to stand in front of the horse, but not as to obstruct the Judge's view. Headers may hold the horse, ONLY in the event of a safety issue.

**25.** Any bad checks, including non-sufficient funds, account closures, fraudulent, etc., will result is the immediate termination of membership and parties will be subject to prosecution with all points earned forfeited. All checks must be made good within ten (10) calendar days after receipt on show day. Reinstatement of membership(s) shall be determined at the next scheduled Board Meeting. A \$30.00 bad check fee per check will be imposed.
