**\*\*Breakdown Sunday AFTER Log Show ends. NO EXCEPTIONS!!!!\*\***

- **Booth spaces will be assigned.** You will receive your space assignment during check in/set up time (TBD) and detailed information about set up a few days prior to the event.
- Sale/distribution of drug paraphernalia, cannabis, stink bombs, and silly string is strictly prohibited.
- The Buckley Chamber reserves the right to approve (prior to or day of) all products sold at the Street Fair and determine what is allowed. If requested, you will need to submit photographs and descriptions of all goods intended to be displayed or sold in your booth.
- **NO OVERT POLITICAL ITEMS ALLOWED with the EXCEPTION of Candidates running for local office or the 31<sup>st</sup> Legislative District Republican/Democrat Organizations**
- **Please bring your own garbage cans.** The Chamber provides garbage cans for patrons of the street fair and not for vendor booths. All vendors are required to clean up debris in their immediate area after closing time on both days. A Garbage Container will be provided at one end of the street fair for vendors to use to dispose of their garbage.
- There are **NO** electrical or water hook-ups available. Generators are permitted. If you are bringing a generator, please indicate above.
- **Payment “in full” must accompany this registration form** and all vendor space fees are **non-refundable. \*\*\*(see below)\*\*\***
- All food vendors are required to comply with all applicable Tacoma Pierce County Health Department codes, requirements and permits. Contact Tacoma Pierce County Health Department at 253-798-6456 no later than two weeks in advance to avoid late fees. **These permits are required and will be checked on site the days of the fair.** I understand that any additional expenses for food permit, city licenses, etc., are my sole responsibility.
- The Buckley Chamber will provide all marketing materials which we will send out via social media links for you to share. Due to the uncertainty of

- I understand the Chamber must comply with any current State-mandated restrictions related to COVID-19. I agree to follow State and County safety and health guidelines.
