Contact Tacoma Pierce County Health Department at 253-798-6456 no later than two weeks in advance to avoid late fees. **These permits are required and will be checked on site the days of the event.**
- I understand that any additional expenses for food permit, city licenses, etc., are my sole responsibility.
- The Buckley Chamber will provide all marketing materials which we will send out via social media links for you to share. Due to the uncertainty of Covid-19 restrictions, we ask that you do not create/share your own marketing materials for the Street Fair.

I understand the Chamber must comply with any current State-mandated restrictions related to COVID-19. I agree to follow State and County safety and health guidelines.

I understand and agree to release the City of Buckley, the Buckley Chamber of Commerce, the Buckley Log Show Committee, and their agents from liability for any claims or suits that arise from the use of the city property for this event.
