### Commemorative Celebration – Vendor Registration Information

Vendor spaces will be located on Lincoln Avenue between A and E Streets in Lake Wales, Florida. All participants **must adhere** to these rules to ensure a safe, respectful, and organized event. Failure to comply may result in immediate removal.

#### Important Vendor Details

##### Event Duration:

- Vendor spaces are available for two (2) days:  
**Sunday, January 18 – Monday, January 19, 2026**
- Booth and food truck locations will be assigned by the Dr. MLK Jr. Weekend Director, Edwina Mackroy-Snell, ON A FIRST COME FIRST SERVE BASIS. Each vendor must display the MLK decal provided.

##### Setup & Breakdown:

- Setup begins: Sunday, January 18 at 8:00 AM – 2:00 PM & Monday, January 19 8:00 AM – 11:00AM.
- **NO VENDORS WILL BE ALLOWED TO SET UP ANY OTHER TIME!**
- Breakdown and Clean Up MUST be completed by: Monday, January 19 at 10:30 PM.

##### Cleanliness Deposit:

A **\$50 refundable deposit** is required to ensure vendor areas are left clean.

- Deposits will be returned upon inspection and approval of cleanliness.
- Deposits will not be refunded if the area is left unclean.
- This is a **City of Lake Wales requirement**.
- **Deposits may be picked up in person on Wednesday January 21, 2026 at the following location: 24 West Orange Avenue, Lake Wales, Florida 33853.**

## Registration Fee

- Standard 10' x 10' booth (tent): \$200 + \$50 (Cleanliness Deposit) = **\$250**
- Food trucks: \$275 + \$50 (Cleanliness Deposit) = **\$325**
- Oversized booth (up to a 10' x 16' tent): \$275 + \$50 (Cleanliness Deposit) = **\$325**
