MAFFI Newsletter Minute - September - October, 2022

As you will have read in the MARC Model A News and the MAFCA Restorer magazines by now the Model A Museum celebrated its 10th anniversary at Model A Days on September 16-17 on the Gilmore campus near Hickory Corners, MI. Those same magazines will have published the MAFFI Hall of Fame (HOF) inductees for the 2022 year. You, however, will probably not read any of the inductee's acceptance speeches.

Howard Minner's became the first person to make his HOF acceptance speech live at the MAFFI Annual Membership Meeting, using "ZOOM" and seen on a big screen television. Below are excerpts from his remarks that history buffs of the Model A hobby will find interesting:

"Two milestone events stand out and I'll make them very brief. Once MAFFI decided to establish a museum, two issues became an immediate focus.

'The first was the obvious question of where the museum would be located. I ended up spending time with other Board members, personally visiting a number of possible sites. Among them the AACA Museum in Hershey, the Henry Ford Museum in Dearborn, the Petersen in California, the Gilmore, of course here in Michigan and the Early V-8 Museum outside of Auburn, Indiana. The latter had been a prime consideration. But MAFFI Board members subsequently visited the Gilmore and agreed this is where we wanted to be.

'Thereafter, the question arose, what should our museum look like. I, along with Loukie Smith and Stan Johnson, came together and brought along pictures of various Ford dealerships from the Model A Ford era. By chance, I brought along a May 1929 article from a magazine called Ford Dealer and Service Seal. This was a private magazine for dealers and edited by Mary Bronstein. (Page 40) showed a front face view of a suggested medium size Ford dealership building. That drawing eventually won the day, and that is what you now see as the facade of our MAFFI Museum here at the Gilmore."

You now know, "the rest of the story".

Dr. Calvin Englemann - March 25, 1932 - November 2, 2022

Dr. Englemann was a past member of the Plain Ol' A's.

Dr. Calvin Englemann died peacefully on November 2, 2022. Calvin was born March 25, 1932, in Pawnee City, Nebraska to Reverend Alvin Englemann and Martha Achenbach Englemann. He moved at the age of ten to Alma, Kansas, where he attended Alma High School and graduated valedictorian.

Calvin attended the University of Kansas for undergraduate (B.A., Chemistry, 1953) and medical school (1957) studies. He completed an internship at Kansas City General Hospital and then a two-year tour as a medical officer with the U.S. Army, stationed in Wertheim, Germany (1958-1960).

Calvin returned to Kansas City and was a surgical resident at Kansas City General. He was in private practice at Baptist, St. Mary's, Trinity, and St. Joseph hospitals until 1994. After retirement, Calvin started a medical clinic in Honduras and enjoyed time at family farms in Kansas.

In 1955, Calvin married Anneliese Schnierle, and they had a wonderful marriage until her passing in 2011. His favorite memories with Anneliese were their many trips together, with family, and with friends to Germany.

ALL FIRED UP

Mary and I were invited by my brother Don to go to the 1990 Omaha Regional Model A car show. Don was in the process of restoring his 1931 Model A Fordor sedan, so we made the trip in our Aerostar Ford Van. We enjoyed the cars so much that we decided we wanted our own Model A. We decided on a 1929 Model A Sport Coupe belonging to Dean Weller.

Dean completed restoring the car July, 1983. I received a log from Dean that covered the maintenance, parts and accessories, car shows and parades attended from July 1983 to September 1990 when we purchased the car. Dean won several trophies at various car shows.

We purchased the car from Dean on September 6, 1990 and won second place at the Olathe Car Show on September 7, 1990. September 25, 1990 we joined the Plain Ol' A's. The Desoto Days 1990 Car Show was next ... we won First Place. At the Lathrop Antique Car and Tractor Show we won Second Place. With several other club members we traveled to the Pikes Peak Classic. We traveled 1,000 miles by way of Nebraska and Wyoming. We won Third Place at the regional show.

A week after the Pikes Peak Classic all of our good luck went out the window. On my way home from my brother Don's house my car caught fire. I got out of my car to check the water in the radiator. While I was filling the radiator I noticed smoke coming from the engine compartment. I raised the hood and saw that the engine was on fire. The paper air filter located next to the exhaust pipe had become saturated with gas which caught fire, melting the in-line plastic fuel filter.

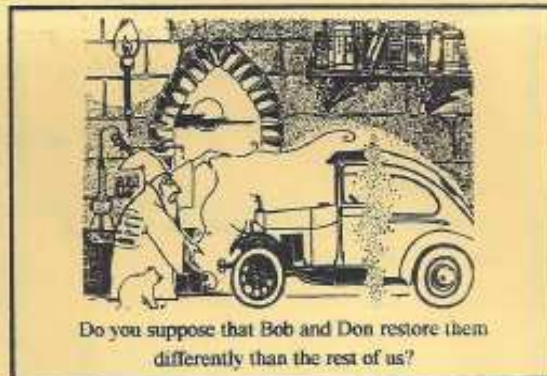
When the car was restored the air cleaner was replaced with a K&N Hi-Flow Air Cleaner. The air

cleaner is advertised by E.S.C. Industries in the *Restorer* magazine. The air cleaner was mounted above the exhaust pipe. The fuel filter was replaced with a metal filter.

With the help of my brother Don and his son Mike, the car was restored in nine months. The chassis had to be removed from the frame, so the car was completely dismantled and reassembled. All of the parts that were not original equipment were replaced. The car was painted Niagara Blue and Duchess Blue with Straw Yellow wheels.

Don completely rebuilt the engine. The crankshaft and other moving parts were balanced. New pistons, rods, valves, water pump, and components were installed. With the new metal valve stems, windshield wiper, carburetor, shocks and shackles, top and tires, the car was ready for the MAFCA National Convention in Dallas.

In June, 1992, we traveled with five other members to the MAFCA National Convention in Dallas. Our

1929 Sport Coupe won Second Place in the Touring Class. In the 1992 Lenexa Parade, a corvette took first place, we came in second with our 1929 Model A.

MY MODEL T EXPERIENCE

"An Ed Kluber Story"

I grew up in the small central Kansas town of Wilson during the depression. My father worked as an engineer at the municipal power plant and was previously an auto mechanic. (didn't Henry Ford do something like that? ed.) One day, when I was about ten or eleven, I was riding with my dad past the local dairy at the north edge of town. My dad pointed out an old truck parked next to a barn and told me it was a Model T truck that had been the city fire truck years before.

Dad bought the truck and pulled it to my grandmother's place at the edge of town (must have been the other edge. ed.). The truck was put into an old barn where I helped overhaul it. I was the go-fer during that time. It was interesting to learn about the use of a so-called hot-shot battery to start the "T". We would place four wood encased ignition coils behind my grandmother's kitchen cook stove to keep them dry.

After the truck was running I was allowed to drive it around the yard. This was easy since I only had to push the low or reverse pedals down to make it go. The seat was just a board on top of the gas tank and if I leaned back I could use the front of the truck bed as a backrest. This seems crude by later standards but it was so exciting then that it didn't matter. The truck was open cab with only the windshield for protection.

Several times dad and I would travel about fourteen miles into the country to get loads of wood for use in my grandmother's wood stove. I would get to drive part way sitting between my dad's legs. The wood was picked up at the bottom of a deep valley in the pasture. Coming up the steep rise, the truck would start to miss and backfire because the engine couldn't get gasoline by gravity feed from the tank. When this happened dad would just press the reverse pedal, turn the truck and back up the hill. What fun!

By the time I had learned how to crank the "T" to get

it started, I would ride by bicycle to my grandmother's, start the "T", and drive it out of the barn and around the yard in low and reverse and then back it into the barn. One afternoon I started the "T" and was standing watching the engine run when I noticed the brass nut holding the spark plug wire on the plug was loose. My dad had taught me to use only one hand when working around electricity, so I put one hand behind my back and grabbed the spark plug nut with the other. ZAP! I got shocked at my finger, elbow, and where my legs were touching the fender. I stood back and told myself that I was grounded on the fender and if I stood away from the fender and having rubber sole shoes, I'd be okay. So I bent over the fender and grabbed the plug again. ZAP! Shocked again. I was now confused about electricity so I put the "T" away.

Later my cousin, who was one and a half years older than I, came to visit and we were running the "T". It wasn't running quite right so my cousin said we should shut it off and take out a spark plug. I don't know what we were supposed to find. We took out the plug and the same brass nut that I had touched when I was shocked, fell into the spark plug hole. That worried me but my cousin said not to worry because it went into the water jacket and wouldn't hurt anything. We put the plug back in and started the engine. It ran terribly, so we shut it off and went home.

I thought about it for several days and then told my dad what had happened. He got a little excited. Later we took the head off the engine and there was the brass nut stuck under a valve. We put the engine back together and it ran fine.

My dad then told me not to believe everything my cousin told me. Dad sold the truck later on and I learned to drive newer vehicles but I have never forgotten my experience with that model "T".

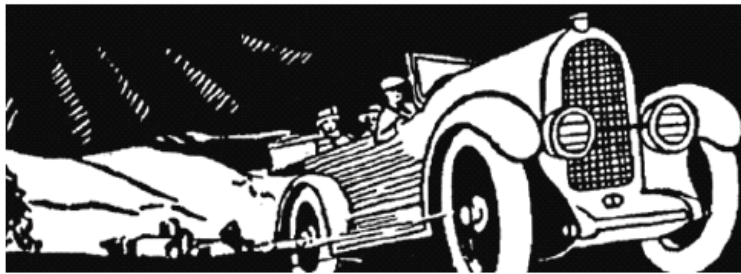

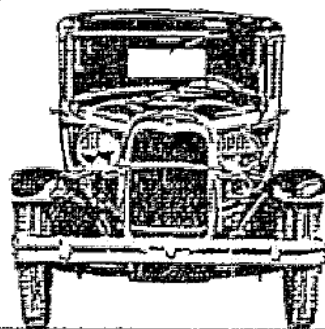
