

ENTIFY – Identity Creation Whitepaper (Affidavit System)

1. Purpose of the Affidavit System

ENTIFY introduces a radically human-centric approach to digital identity creation. Instead of relying on passwords, corporations, or state institutions, ENTIFY defines identity through a self-signed, self-owned affidavit backed by a combination of:

- Practiced Magic Symbols (private kinetic biometrics)
- Autograph (public symbolic biometric)
- Voiceprint (vocal biometric)
- Facial pattern (visual biometric)
- Fingerprint (physical biometric)
- NFT hardware private keys
- User-declared copyright over all biometric data

The affidavit is the moment of identity birth.
It establishes:

1. Intent
2. Volition
3. Honesty commitment
4. Copyright over all biometric expressions
5. The user's own authority over their identity

2. Controlled Natural Language Version (Human-Readable)

This version is designed to be clear, precise, unambiguous, and suitable for everyday users while still formally meaningful.

(Controlled Natural Language)

1. I declare that I am a living man/woman.
2. I declare that I am the source and owner of my consciousness, my decisions, and my actions.
3. I declare that all biometric expressions generated by me— including my face, voice, fingerprint, autograph, and magic symbols—are my personal property.
4. I declare exclusive copyright ownership over all of my biometric data. No man/ woman/person or organisation has permission to use or copy my biometric data without my voluntary consent.
5. I declare my intent to act with honesty, integrity, and non-harm within the ENTIFY network.
6. I declare that I take full responsibility for the use of my ENTICARD, ENTIFONE, autograph, and magic symbols.
7. I declare that I understand that authentication requires my conscious action and deliberate intent.
8. I declare that any witness who verifies this affidavit is verifying only that I performed this declaration and presented myself as a living man/woman.
9. I declare that this affidavit becomes part of my immutable ENTIFY identity record and is secured by my private keys.

3. Machine-Parsable (“Computer Code”) Version

This is not programming code; it is machine-consumable declarative identity data formatted in a deterministic structure. It can be stored on-chain, hashed, or encoded into NFT metadata.

4. How the Affidavit Connects to the Biometrics, Autograph, and Secret Symbols

4.1 The Magic Symbols (Private Keys of the Human Body)

The three secret Magic Symbols are:

- motor-memory based
- extremely difficult to imitate
- used as primary device unlock
- treated as the human equivalent of a private cryptographic key

They represent inner intention, known only to the user.

4.2 The Autograph (Public Identity Key)

The affidavit legally and technically establishes:

The ENTIFY system links the affidavit to the biometrics using:
