2022-2023 OSA MEMBERSHIP RENEWAL AND 2022 SUBURBANICE MACOMB SUMMER ICE REGISTRATION

OSA Membership Renewal drive: Monday May 9th through Sunday May 15th

All current OSA and U.S. Figure Skating memberships expire as of June 2022. Memberships must be renewed in order to register for the Summer Skating Contract. Membership applications are available online ONLY! For renewal, please visit www.onyxskatingacademy.com and click on the Entryeeze membership logo.

SafeSport Compliance:

In 2018 as a part of its SafeSport Program, U.S. Figure Skating announced it has expanded the list of adults required to complete SafeSport training and background checks for each membership year. This will affect members and volunteers, over the age of 18, who are in a position of authority over an athlete or anyone who has frequent contact with athletes. This includes all volunteers in any sanctioned events or club activities who come in contact with athletes and locker room volunteers for all competitions, ice shows and club events. This is not an OSA mandated program; it comes from U.S. Figure Skating! In order for our club to stay SafeSport compliant, we are requiring all parent volunteers to complete this training. Service hours will be given for your time. SafeSport training and/or refresher courses must be completed every year. Background Checks are valid for the season in which a determination is issued and the following season with a 12 month automatic recheck.

Seniority Numbers:

Seniority numbers were assigned on July 1, 2021 to all members for the 2021-2022 membership year. A new seniority number will be issued on July 1 for the 2022-2023 membership season. That seniority number will be issued for the 2022 Summer Ice Contract Registration and the 2022-2023 FWS Skating Season.

Payments:

Summer Ice Contracts may be split into two payments with 50% due at the time of registration and the remaining 50% due on or before July 15th. Payments may be made with cash or checks (made out to Suburban Ice Macomb) or credit/debit card. If using a credit/debit card you will automatically be enrolled in Auto Pay. Payment two will automatically come out on July 15th. All contracts totaling under \$375 must be paid in full at registration. Returned Checks are subject to a \$40 NSF Fee. It is very important that payments be made on time, otherwise ice privileges may be suspended at the discretion of Suburban Ice Macomb. Payments a week late will be subject to a \$25 late fee. For skaters who choose not to contract for the Summer, you may purchase drop in passes for \$15 per session if there is space available.

Ice Time Changes:

Changes to the summer contract will only be allowed until Friday July 1st with a fee of \$15.00. After this date, there will no changes allowed under any circumstances. There will be no deletions allowed to your contract once the summer skating season has begun.


Registration: Tuesday May 24th through Tuesday May 31st
