



2) WHEREAS the Founder of the Trust, for the above said purpose have set apart a sum of Rs.1,000/- (Rupees One Thousand only)initially as a fund for the Trust to be managed and administered by the Board of Trustees on the terms and conditions and rules and regulations hereinafter laid down and where this sum of Rs.1,000/- (Rupees One Thousand only) has this day, been handed over to the Board of Trustees.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1)The Authors of the Trust hereby declare and create a TRUST known as "SRI SABARI EDUCATIONAL TRUST" hereinafter called the 'TRUST"

The Registered Office of the Trust shall be situated at NO:107/2,Pandian Nagar 6th Street, "SABARI ILLAM" Kariapatti, Virudhunagar District-626 106.

The Board of Trustees through a resolution in writing to such effect may change the Registered office of the Trust or establish branch office elsewhere.

2(a). As on date, there is no fixed assets in the name of the trust.

3.THE OBJECTS OF THE TRUST ARE:

1)To establish primary, higher secondary and matric schools, technical and Professional course and provide education facilities in Urban and Rural areas.

2)To formulate scholarship schemes to encourage the students to accomplish high standard of education.

3)To provide and maintain schools, colleges, institutes(English and Tamil Medium) for imparting education, and maintain boarding houses, hostels etc., for the students studying in the said schools, colleges and institutes besides promoting higher education, post graduation and overseas studies.

4)To supply books, dresses and other paraphernalia incidental to the provision of education and medical facilities to the children and youth.

5)To establish, develop, maintain and grant aid in cash or in kind to hospital, medical, schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centres and or such other similar charitable institutions in India for the benefit and use of the general public.

6)To establish , run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.

7) To develop retreat houses and libraries to the venue of Seminars, Conferences, etc., for vocational and other groups, run training Camps and Courses and organize conferences, seminars etc., for the promotion of the aim and objects of the society.

8) To enter into any arrangement with the Government Central or State with local Authorities in pursuance of the objects of the Trust and by obtaining from such Government or authority all rights, concessions and privileges that may seem conducive to the objects of the society.

9) To set up homes and training centres in aid of the physically handicapped and mentally retarded people Health Centres and Hospital with or without the grants from the Government.

10) To open De-addiction Centres for the Rehabilitation of addicts and alcoholics and relieve the addicts of their deadly habits and also to organize De-addiction and Rehabilitation camps and Awareness programmes.

11) To establish Home for the Aged and Destitute with a singular aim of total rehabilitation.

12) To develop projects in the field of vocational Training like Typewriting ,Tailoring Condensed Courses, Professional courses, Printing etc., and work for women development.

13) To accept Donation, Grants, Gifts, Presents in cash and in kind for the objects of the Trust.

14) To donate in cash or in kind to all causes of similar objects and charitable purposes by reason of their locality or operation or otherwise.

15) To receive endowments for any specific purposes of the above types and administer them separately.

16) To do all acts deeds and things incidental to or necessary for the fulfillment of the aforesaid objects.

17) To form , run and maintain Hospitals to provide medical facilities for the welfare of poor peoples.

18) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people orphans, widows and aged persons.

19) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.

20) To help the unemployed youth in all possible ways in order to make themselves self-reliant and self-supportive such as by giving training in tailoring, TV and Radio mechanism, computer, type writing, weaving etc.,

21) To promote rain water harvesting in Rural, Urban areas, houses, buildings etc., to increase Ground water level and to preach the importance of rain water harvesting and develop social forestry and to work to put an end to deforestation and propagate.

22) To establish Shelters, Fodder, Medical facilities for the Stray Animals like Cow, Goat, Sheep, Dog, Bulls and Other Domestic Animals.

The above Aims and Objects shall be independent of each other and the Board of Trustees and as constituted with Founder author members may apply, from time to time, the funds of Trust in carrying out all or any of the aforesaid objects of the Trust as it may in its absolute discretion deem fit.

4. TRUST FUND:

The Trustees shall hold a sum of Rs.1,000/- (Rupees One Thousand only) paid to them by the Author which shall form the corpus of the Trust to be applied together with any accrued income thereon for the promotion and encouragement of the objectives of this Trust.

II. The funds of the Trust shall be invested:

a) In any of the securities authorized by section 20 of the Indian Trust Act, 1882 OR

b) In the purchase of land agricultural house sites, buildings or in the construction of buildings, provided that no such investment shall be made except with the previous sanction of Board recorded by means of a resolution

1) CONSTITUTION:

II. All the Trustees who are, for the time being and from time to time , in office shall constitute and be referred to collectively as the "BOARD" of trustees of the Board.

III. No person shall hold or continue to hold office or be appointed as a Trustee and the Trustee's Office shall be Vacant if

- a) He/She is found to be or become a person of unsound mind
- b) He/She is convicted of all offence involving turpitude
- c) He/She is adjudged insolvent.
- d) He/She is suffering from physical infirmity which renders him/her unfit for active work.
- e) He/She is in the opinion of co-trustees after due enquiry found guilty of breach of Trust gross negligence or dereliction of duty.

f) He/She is , in opinion of co-trustee after the due enquiry found or become disqualified to act as the trustee according to the law the act as the trustee according to the law for the time-being force, governing the Trust hereby declared and created.

IV. Whenever any person appointed as a Trustee disclaims or any such Trustee, either original or substituted dies or is, for a continuous period of Five years absent from India or leaves Indian for purpose residing abroad and desires to be discharged from the Trust or Trustees or becomes, in the opinion of a principal civil of original jurisdiction unfit or personally incapable of acting as Trustee or acts in a manner inconsistent with the objects of the Trust from his Trusteeship. A new Trustee will not be appointed in his/her place by the Board.

V. If a Trustee resigns or voluntarily goes out of the Trust, the Board will appoint new Trustees.

VI. Any vacation of office by Managing Trustee or Chairman or Secretary shall be filled up by the Board of Trustees which shall elect amongst themselves Managing Trustee or Chairman or Secretary as they case may be.

VII. A Trustee resigning his/her office or otherwise ceasing to be a Trustee shall not be reason to that fact alone, be relieved from his/her co-Trustee in respect of his/her acts of commission or omission or defaults during the period of his /her Trusteeship.

VIII. Subject to the provisions herein contained, each of the Trustee shall be respectively chargeable only for such moneys, stocks and securities as he/she may have actually received and shall not be answerable one for the other of them not for any Banker, Broker or other person in whose hands any property of the Trust may be placed , nor for any insufficiency or deficiency of any stock, funds or securities not otherwise for any accidental loss.

POWERS OF THE OFFICE BEARERS OF TRUST:

In the absence of the Chairman the Trustees present may select among themselves, a Trustee to chair the meetings.

1. CHAIRMAN:


a. The chairman of the Trust shall be Nominal Head of the general bodies of Trustees.

b. The Chairman will hold the office for the period of 2 years from the date of Nomination.

2. MANAGING TRUSTEE:

a. The Managing Trustee of the Trust shall preside over all the meetings of the general bodies of Trustees.

- b. The Managing Trustee shall direct the other officers to execute the resolution of the Trust.
- c. The Managing Trustee is empowered to execute the decisions of the Trust.

3. SECRETARY:

- a. The Secretary in consultation with the Managing Trustee shall convene the meeting of the Trust.

- d. Recording the minutes of the Trustee as well as the executive/sub-committee meeting.
- e. Bank account or accounts shall be opened and operated by both the MANAGING TRUSTEE and SECRETARY Jointly.
- f. The Secretary will hold office for the period of 2 years from the date of nomination.

POWER AND DUTIES:

- 1. The Trust may acquire movable and immovable property for the purpose of carrying out the objects of the Trust.
- 2. The BOARD shall have power to sell and dispose of any of the properties of the Trust and apply the proceeds of such sale for and/or in connection with and/or in furtherance of and/or the carrying out the objects of the Trust or for the purpose of any institution that may be established, maintained or run by the Trust.
- 3. The Board shall have power to accept any contribution in each or kind by way of additions to the Trust funds generally or for any one or more specified objects of the Trust and in either case such contributions shall be dealt with according to the directions, if any of the Donor at the time of gift provided the direction is in conformity with the object of the TRUST.

4.The BOARD shall have full power of Management of Trust properties and funds and it shall have full control over the finance of the Trust. It shall likewise, have full powers or supervisions over all institutions and establishments as that may be maintained and conducted in terms of the Trust hereby created.

5.The BOARD shall have power to levy fees or charges from the persons benefitting from the institutions and establishments maintained and conducted by the Trust and exempt deserving persons from fees or charges that may be fixed by the Board from time to time.

6.The BOARD shall have power to apply for and obtain grants in aid from the Government or any other constituted authority or body and settle the terms on which such grants may be obtained.

7.The Chairman, Managing Trustee and Secretary will be selected away the Trustees once in 2 years on rotation basis.

8.Any grants-in-aid received shall be strictly applied for the purpose for which such grants may be have been made.

9.Whenever, for the administration of the Trust hereby created or for the purpose of any institution established, maintained, or run by or under the Trust hereby created, grants-in-aid from Government or any other constituted authority or body , are applied for and obtained it becomes necessary for the due performances of the conditions of such grants to secure the same by mortgage or charge on the properties of the Trust, the Board shall have power to create such mortgage or all or any of the Trust properties to facilitate the obtaining of such grant-in-aid.

10.The Administration , direction and Management of the Properties of the Trust and of the institutions and the establishments maintained or run by the Trust hereby created shall, subject to the supervision, control and directions of the BOARD, be with the Managing Trustee.

11.The Managing Trustee shall if an and when so authorized by a resolution of the Board, have power and authority to execute such documents as are necessary in favour of Government or other authority or body for and on behalf of the Board and in respect of mortgages to be created for and in connection with obtaining grants-in-aid.

12. Except as otherwise provided herein none of the Trustee for the time being of the Trust shall have power to mortgage or charges or alienate any of the Trust properties.

13. The trustees shall have power to borrowings loan from banks and other financial institutions and also from private establishments and individuals for implementing any other objects for the trust. The Managing Trustee shall have also power to mortgage or charge the properties of the trust or any part thereof to secure repayment of any such or sums of moneys which the trustees any borrow on the security thereof.

14. The Managing Trustee shall arrange for the maintenance of correct and proper accounts of the receipts and disbursements and of the liabilities incurred and of the assets acquired and for an audit every of the accounts of the TRUST and of the Income and Expenditure relating there to and for this purpose, the Managing Trustee shall appoint consultation with the Board, an independent, auditor or auditors.

15. The Managing Trustee shall have custody and control of all the documents of title, to the properties of the Trust and all other documents accounts or other papers relating to the Trust and the same shall be open to the inspection by any Trustee on reasonable notice during the office house of the Trust. The Managing Trustee on request by any Trustee(s) furnishes Such information as the letter may reasonably require in respect of any matters pertaining to the Trust.

16. The Managing Trustee shall once in every not later than 31st July place before the Board, the Income and Expenditure account for the year ending on the 31st March and the Balance sheet as on that day, with the Auditor's report certificate (if any) thereon. The Managing Trustee shall give to the Board such information and explanation as the Board may require for a proper understanding of the accounts and the statements place before it.

17. The Board of Trustees is hereby empowered to nominate not exceeding three persons as the patrons of the Trust and the patrons shall be functioning in an advisory capacity.

18. The Managing Trustee shall be the executive officers of the Board and as such shall have power and authority for and on behalf of the Board.

MEETINGS:

1. There shall be 'ANNUAL MEETING' of the Board when the annual audited statements of accounts shall be considered and adopted. The Managing Trustee shall at such meeting, place before the Board a Report on the working of the several institutions conducted and maintained by the TRUST. The Managing Trustee shall at least 14 days written notice of the meeting to the Trustees specifying the DAY, DATE, PLACE, TIME AND AGENDA of the meeting.

2. The Board shall consider at the said meeting the report of the Managing Trustee and that of the Auditor and the audited accounts and, of the Board proceeds to approve and adopt them such approval and adoption shall be by means of a resolution to that effect. The Board shall also transact such other business at that meeting about which due notice had been given as aforesaid. All the resolutions passed by the Board shall be recorded in separate book. Any one of the trustees may be appointed to preside over the meeting.

There shall be a notice of at least 14 days for every meeting so convened. VI. GENERAL:

1. The Trustee shall confirm to the provisions of the INDIAN TRUST ACT, 1982 in all matters not expressly provided for herein, but in case of any difficulty or doubt arises on any question in respect of the Management or Administration of the Trust or any matters falling herein before the Managing Trustee on behalf of the Board apply to the court for opinion, advice, directions, if any of the court shall be deemed, as regards responsibility to have discharged their duties in respect thereof.

2. The Board is hereby authorized to, and it may from time to time made and prescribe additional Rules and Regulations of the Trust at for and in connection with the Management of any of the Institutions established, maintained or run by or under the Trust Hereby erected.

3.If at any time, the objects of the TRUST should become impossible of fulfillment, the properties and funds belonging to the Trust shall be utilized for such other allied purpose as the Board may determine or shall be transferred to similar to those of this Trust and which is recognized under Section 80-G of the Income Tax Act. 4. It is hereby expressly declared that this Trust is a Public Charitable Trust and the Trust hereby declared and created is irrevocable.

5.No amendment to the terms of this Deed shall be made without obtaining the prior written permission of the Commissioner of Income Tax. However, the amendments to be carried out shall not infringe the provisions of section 2(15), 11 to 13 and 80-G of the Income Tax Act,1961.

6.The objects of the Trust shall be achieved without involving any activity for profit.

7.The Trustees shall not be entitled to the benefit of the Trust.

8.The trust formed is irrevocable.






10.The benefits of the Trust shall be open to all Indians irrespective of caste, creed, or religion.


