Long Arm Committee – Debbie Arsenault - The longarm committee just finished their first new certification class and have now successfully trained 8 new members, totalling 85 currently certified members to our longarm.

We changed the <u>Machine User Issues</u> form on the website, (which people were not filling out). We now have a <u>Longarm Session Summary</u> form that is mandatory to fill out at the end of each session.

OLD BUSINESS:

- 1. VP Document for Luncheon Coordination: A document summarizing the details and timeline for luncheon coordination will be reviewed.
- 2. President Elect Job Description: Review and approval:

Linda reported this proposal at the last general meeting. The question was what the job description would be. NEW BUSINESS:

Ribbons for Quilt Show: Examples from Jan Octerbeck will be shared with the board.

501 3C Organization: It has been recommended by Carla Peccianti that we do this because it can significantly reduce our supply costs. For example: If we are a 5013c Linda's sewing shop would give us a 30% discount. They are now charging a flat rate of \$9.90 for shipping whether we order one or more rolls of batting. The current sale is 25% for batting at \$187.49/roll versus 249.99/roll. If we were 5013c it would be \$175/roll a savings of \$12.49/roll which would cover shipping cost.
