President:

CAC Expansion:

At the last meeting CAC Presidents meeting we learned:

- 1. Ideally the transition date could be as early January 2027 to align with the fiscal year. However, Robson legally has until September 2027 for the transition to occur.
- 2. There are changes within the family. As Ed Robson is aging, the family is determining the succession. In addition, Karen Taylor Robson is running for Governor which may impact her availability in their discussions.
- 3. The Transition Advisory Group and HOA board continues to be supportive of the CAC expansion or more likely a new building as a request for a woodworking shop has also been made. All CAC clubs are in need of more space. As of April 2025, they have \$207,990 in the bank! Accumulated CD interest since inception: \$5,547.

Motion for Bylaws Change:

At the last board meeting, we discussed the need for having a better transition plan for the board. We are planning to hold a vote for a change in bylaws to change from having 2 VPs to having a President Elect who would automatically transition to President and 1 VP. We are planning to send out a new Job Description for the President Elect and revised Job Description for the Vice President in advance of the next election.

Discussion:

Question: Why not just eliminate one of the VP positions and make that person the President Elect.

Answer: We need an odd number of members on the board to have a majority during votes.

Question: How will the President Elect position differ from the VP position?

Answer: The current VP role includes coordinating the Spring and Holiday Luncheons and has recently taken on the role of scheduling programs for the general meetings. In addition, the VP may sub for the President at meetings as needed. The President Elect Position will focus on activities to prepare the candidate to assume the president role. These will be fully listed in the Job Description.
