**CONTRACT**

1. Owner/Representative agrees to pay the posted rate for boarding in effect on the date pet is checked into the kennel.
2. Owner/Representative understands boarding rates are charged by the day, including full daily boarding rate the day of drop off and the day of pick up.
3. Owner/Representative agrees to pay all costs and charges associated with pet during the time said pet is in the care of the kennel, including but not limited to special boarding request and veterinary charges.
4. Owner/Representative agrees that the pet shall not leave the kennel until all charges are paid.
5. Maximum days of boarding may not exceed 30 days
6. Owner/Representative certifies all contact and pet information is accurate and correct.
7. It is the responsibility of the Owner/Representative to provide updated contact and pet information.
8. Kennel shall exercise responsible care for the pet delivered by the Owner/Representative to kennel for boarding. The Owner/Representative further agrees to be responsible for all acts or behavior of said pet while it is in the care of the kennel. If Owner/Representative's pet(s) becomes ill, injured, lost or deceased while under Kennel's care, Owner/Representative will be responsible for all charges associated with the injury.
9. Owner/Representative specifically represents that he/she is the sole Owner/Representative of the pet, free and clear of all liens and encumbrances.
10. Owner/Representative releases and waives all claims and liability against Kennel for damage to, or loss of, personal equipment or belongings provided by Owner/Representative for pet(s).
11. Owner/Representative represents to Kennel that pet(s) is current with all vaccinations including the DHLPP, Rabies and Bordetella for canines and Rabies and FVRCP for felines during all visits to the kennel.
12. All charges incurred by Owner/Representative shall be payable upon pick up of pet or when billed by kennel at address listed on contract. The Kennel shall have and is hereby granted lien on the pet for all unpaid charges resulting from boarding pet the Kennel. The Owner/Representative agrees that in the event the boarding charges are not paid when due in accordance with this agreement, the Kennel may exercise its lien rights upon 14 days written notice given by Kennel to Owner/Representative by certified mail to address shown on agreement. Kennel may dispose of pet for all unpaid charges at private or public sale in adequate to pay such costs of board or other charges delinquent, plus costs of sale than Owner/Representative shall be liable to Kennel for the difference. All monies realized to Kennel at such sale, over and above charges due and costs of sale shall be paid by Kennel to Owner/Representative. A 2% monthly service charge will be applied to any account not paid within 30 days.
13. If pet becomes ill or if the state of the animal's health otherwise requires professional attention, the kennel in its sole discretion may engage the services of veterinarian or administer medicine or give other requisite attention to the animal and the expenses thereof shall be paid by Owner/Representative.
14. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representative and assigns the Owner/Representative and the Kennels.
15. In the event it becomes necessary that the Kennel turn over a delinquent account to an attorney or collection agency, including but not limited to, court cost and attorney's fees.
16. Owner/Representative must provide a credit card or debit card at check-in.
17. A \$35 service charge will be made for all payments returned for insufficient funds or for any other reason.
