CERTIFICATE OF AMENDMENT TO THE DECLARATION OF RESTRICTIONS THE INDIAN TRAIL HOMEOWNERS ASSOCIATION

WHEREAS, the Declaration of Restrictions for Indian Trail Homeowners Association was recorded in Official Records of Palm Beach County Florida, ORB 3574, PAGE 0226 as amended from time to time.; and

WHEREAS, Article XVI, Section 3 of the Declaration of Restrictions provides that the Declaration may be amended upon the execution and recordation of an instrument by owners entitled to vote a majority of all votes; and

WHEREAS, the owners entitled to vote a majority of all votes of Indian Trail Homeowners Association, Inc., executed an instrument to amend the Declaration as set forth in Exhibit "I" attached; and

WHEREAS, the amendment and this Certificate of Amendment shall be filed and recorded in the Public Records of Palm Beach County, Florida; and

NOW, THEREFORE, the Declaration of Restrictions of the Indian Trail Association shall be and is hereby amended as stated in Exhibit "I" attached hereto; said amendment shall run with the real property known as Indian Trail and shall be binding on all parties having any right, title, or interest in the said real property or any part thereof; their heirs, successors, and assigns, and shall inure to the benefit of each owner thereof; and except as otherwise amended shall remain unchanged and in full effect.

EXHIBIT "I" ARTICLE VII

MAINTENANCE OBLIGATION OF ASSOCIATION

Section 2. Dwellings and Lots. The Association shall at all times maintain the finished exterior surfaces of the dwelling and other improvements as originally constructed by Declarant, including exterior walls, or exterior roof, exterior lights, and fences, but specifically excluding all windows and screening, which shall be the responsibility of the Owner. This maintenance obligation pertains only to the exterior surfaces, any maintenance, repairs, or replacement of improvements under the exterior surface is the obligation of the Owner thereof. The exterior surface maintenance obligation shall be defined as exterior painting, except that the painting of exterior doors and windows shall be the responsibility of the Owner. The maintenance, repairs, or replacement of the T1-11 plywood sheathing and fascia boards not covered by gutters shall be the responsibility of the Association. Fascia boards that are covered by gutters shall be the responsibility of the Owner. All Concrete Block System ("CBS") walls and all stucco is the responsibility of the Owner. Privacy fences and all other wood components such as 2 x 6 and supports are the responsibility of the Owner.

Section 6. Right of Entry by the Association. Whenever it is necessary to enter a dwelling or Lot for the purpose of inspection, including inspections to ascertain an Owner's compliance with the provisions of this Declaration or for the performance of any maintenance, alteration, or repair to any portion of the dwelling or improvement upon the Lot, the Owner thereof shall permit the authorized agent of the Association to enter such dwellings, or go upon the Lot, provided that such entry shall be made only at reasonable times and with reasonable advance notice. In the case of an emergency such as, but not limited to, fire or hurricane, entry may be made without notice or permission. Each Owner herein provided and agrees that the Association shall not be liable for any alleged property damage or theft caused or occurring on account of any entry. If after entering said Lot, the Association determines in its sole discretion that the Owner has not performed its obligations for the maintenance, repairs, or replacement that are the Owners responsibility the Association will provide notice to the Owner of the obligation for maintenance, repairs, or replacement with a thirty (30) day notice to cure. In the event the Owner fails to perform the maintenance, repairs, or replacement, the Association shall cause such repairs to be made and shall bill such cost to the Lot. The Owners failure to pay said assessment shall result in a lien on the Lot and said lien shall be foreclosed.

ARTICLE XVI GENERAL PROVISIONS

* * *

Section 3. Amendment, The covenants and restrictions of this Declaration shall run with the land for a term of twenty (20) years from the date this Declaration is recorded, after which time they shall be automatically extended for successive periods of ten (10) years. This Declaration may be amended at any time and from time to time upon the execution and recordation of an instruments executed by Owners who are entitled to vote of a majority of all votes of the Association. PROVIDED that for a period of three (3) years commencing from the recording of this Declaration in the Public Records of Palm Beach County, Florida the Declarant's written consent must first be obtained The Declarant shall have the right at any time within five (5) years from the date hereof to amend this Declaration to correct scrivener's errors or to clarify any ambiguities determined to exist herein. No amendment shall alter the subordination provisions of this Declaration without the prior approval of any mortgagee enjoying such protection.
