RG Carver reported seismograph recorded a for the January blasts of SCS and Vulcan Quarry. He will provide the screen shot. Our monitor is #8897.

County Commissioner Jo Don Dockery came to report that the County has been working on funding for TXDoT to widen the road to include a left turn lane and 10-foot shoulders on Hwy 71.

The Commissioner requested a resolution for an endorsement of this project from the city, understanding that at this time the city might not be able to help with the funding of the project.

September 2021 is the start date on widening Hwy 71 from Opie's BBQ to the Pedernales River Bridge.

**Motion**: Glenn Leisey moved to draft a resolution supporting the Highway 71 widening improvements for a 3-mile addition of a continuous left turn lane and widening of the shoulder.
