2. Rollcall to Confirm Quorum

Alderman Tom King, John Osborne, Bob Schmitz, Jim Millard were present. Alderman Glen Stafford, City Secretary Karen Maxwell, and Mayor Cathy Sereno were absent. Pilar Chiodo recorded the minutes.

A quorum was met. Alderman Jim Millard, Mayor Pro Temp, presided over the meeting.

4. Pledge of Allegiance - U.S. & Texas

5. Approval of Minutes – September 14, 2023, Regular Council Meeting

Motion: Alderman Schmitz moved to approve the amended minutes.
