On the 10th day of April 2025, the City Council convened at 7:00 pm in the Council Chambers located at 103 Vista View Trail, Suite 100, Double Horn, Texas. Notice of the meeting giving the time, place, date, and subject had been posted as described in Chapter 551 of the Texas Government Code.

- **1. Call Meeting to Order.** Mayor Sereno called the meeting to order at 7:00 pm.
- 2. Roll call to Confirm Quorum. City Secretary Christina McDonald confirmed a quorum, with Mayor Sereno, Mayor Pro-Tem Millard and Aldermen Kimber, Rathe, Stafford and Schmitz present.
- **3. Invocation.** Alderman Stafford gave the invocation.
- 4. Pledge of Allegiance U.S. & Texas. Mayor Sereno led the pledges.
- **5. Approval of Minutes March 13, 2025, Regular Meeting.** Alderman Rathe moved to approve the minutes, seconded by Mayor Pro-Tem Millard. The motion passed unanimously 5-0).
- **6.** Citizen Comments. There were no citizen comments.
- 7. Regular Agenda.
 - A. Marble Falls ISD May Bond Election: Guest Speaker, Superintendent Dr. Jeff Gasaway. Dr. Gasaway shared information regarding the May 2025 bond election and what it means to the school and community.
 - B. Treasurer's Report:
 - i. Monthly Financial Reports. Mayor Sereno presented the February financials. Alderman Schmitz moved to transfer \$1,456.04 from the Property Tax Account to the Operating Account, seconded by Mayor Pro-Tem Millard. The motion passed unanimously (5-0).
 - ii. Discussion and Acceptance of City of Double Horn Annual Internal Audit. Mayor Sereno reviewed the internal audit with the Council. Mayor Pro-Tem Millard moved to accept the internal audit as presented. Alderman Stafford seconded the motion, which carried by a unanimous vote (5-0).

- **D. Zoning & Ordinance Committee.** Mayor Pro-Tem Millard stated that he had received one report of an unpermitted solicitor.

 - i. Cameras installed at East Trail & West Trail. Alderman Stafford provided the update.
 - **ii. TMLRP Insurance impact**. Mayor Sereno stated the cameras have been added to the City's insurance policy.
- F. Discuss and consider action on projects recommended by the Water Conservation Partnership Committee, a joint committee between the City of Double Horn, Double Horn Creek Water Supply Corporation, and the Double Horn Improvement Association to promote water conservation and protect water service.
 - i. Review of WaterSmart Rebate Financial Status Report. The Council reviewed the status report. No action was taken.
 - ii. Discuss and consider action to communicate the WaterSmart Rebate & Education Program. The Council discussed mailing information to all residents of Double Horn.
- G. TXDOT 2026 Project, SH71 Spur to Double Horn Creek (right-hand turn lanes for East Trail & High Plains Trail):
 - i. Update FY 2024-2025 Budget Notes from:

"\$5K-East Trl & High Plains, \$5K West Trl (Date TBD)" to "\$10K - East Trl & High Plains Trl, West Trl TBD" Note: There is no impact on budgeted dollars

Alderman Schmitz moved to update the FY 2024/2025 budget notes allocating \$10,000 for East Trail and High Plains Trail.

- ii. Review and consider action to approve TXDOT AFA Agreement. No action was taken.
