Rebates are available as well as free seminars that provide valuable information to help you to conserve water and continue to be a good steward of your land.

Based on demand and community feedback, free seminars will be conducted throughout the year at the City of Double Horn Office. Seminars include the following topics:

Qualifying Rebates

This program offers rebates for the following WaterSmart purchases, up to \$300 per household/entity per year (rebates exclude labor and taxes):

Rainwater harvesting barrels, tanks, & filters
50% Cost Up to \$300

Drip irrigation equipment/supplies
50% Cost Up to \$300

Manual or solar ring pool cover
Cost Up to \$100

Permanent mechanical pool cover
Cost Up to \$300

Texas A&M AgriLife Extension soil test
Cost Up to \$25

Native & adapted plants *
Cost Up to \$100

Rebate Requirements & Process

- 1) Must be a City of Double Horn Taxpayer
- 2) Residential & commercial property owners must be a registered user of Metron WaterScope if a DHCWSC water customer
- 3) No written notice of violation of water use restrictions within the last 6 months
- 4) Complete an application within 90 days of purchase and submit to City Secretary (drop off or mail)
- 5) Provide itemized receipt(s) (excludes labor & tax)
- 6) Photo of work completed to be used in promotional materials & website (optional)
- 7) Receive a rebate check within 45 days of
