CITY OF DOUBLE HORN, TEXAS ORDINANCE 2020-ORD022

AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE CITY OF DOUBLE HORN, TEXAS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2020 AND ENDING SEPTEMBER 30, 2021; PROVIDING APPROPRIATIONS FOR EACH FUND; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR THE FILING OF THE BUDGET IN THE OFFICE OF THE CITY SECRETARY; AND PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE.

WHEREAS, the Mayor of the City of Double Horn, Texas ("Double Horn") has submitted to the City Council of the City of Double Horn, Texas (the "City Council") the proposed budget of the revenues and the expenditures for conducting the affairs of the City and providing a complete financial plan for the fiscal year beginning October 1, 2020 and ending September 30, 2021 and has filed the same with the City Secretary (the "Budget"); and

WHEREAS, all public notices on the budget have been duly advertised, published and posted on the City's website as required by law; and

WHEREAS, a public hearing was held on September 17, 2020, and all interested persons were given an opportunity to be heard for or against any item within the proposed Budget; and

WHEREAS, after due deliberation, study and consideration of the proposed Budget, the City Council is of the opinion that the Budget should be approved and adopted.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DOUBLE HORN, TEXAS:

SECTION 1: That the appropriations for the fiscal year beginning October 1, 2020, and ending September 30, 2021 for the support of the general government of the City of Double Horn, Texas, be fixed and determined for said terms in accordance with the expenditures shown in the City's fiscal year 2020-2021 Budget as filed in the office of the City Secretary.

SECTION 2: That the Budget, as on file in the office of the City Secretary, is hereby in all respects adopted as the City's Budget for the fiscal year beginning October 1, 2020, and ending September 30, 2021, and that a true and correct copy of the Budget herein approved and adopted shall be filed for record in the office of the City Secretary and it shall be part of the public records of the City of Double Horn, Texas.

SECTION 3: If any provision, section, sentence, clause or phrase of this Ordinance, or the application of the same to any person or set of circumstances is for any reason held to be unconstitutional, void, invalid, or unenforceable, the validity of the remaining portions of this Ordinance or its application to other persons or sets of circumstances shall not be affected thereby, it being the intent of the City Council of the City of Double Horn in adopting, and of the Mayor in approving this Ordinance, that no portion thereof or provision or regulation contained herein shall become inoperative or fail by reason of any unconstitutionality or invalidity of any portion, provision or regulation.
