DECLARATION OF GEOFF WINKLER

I, Geoff Winkler, declare as follows:

1. I am the Court-appointed permanent receiver (the "Receiver") for Defendant Essex Capital Corporation ("Essex") and its subsidiaries and affiliates (collectively, the "Receivership Entities" or "Entities"). I was appointed as Receiver for the Entities in the above-captioned action on December 21, 2018, by virtue of the Court's Order Regarding Preliminary Injunction and Appointment of a Permanent Receiver (the "Appointment Order") (ECF No. 66). I have personal knowledge of the facts detailed in this Declaration, and make this Declaration in support of the concurrently filed Second Interim Application of Receiver, Geoff Winkler, and Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"), General Counsel to the Receiver, for Payment of Fees and Reimbursement of Expenses (the "Fee Application").

2. I have reviewed the Fee Application, and I believe the fee and expense requests identified therein to be fair and reasonable, and to reflect an accurate representation of the work performed. I likewise believe that the estate of the Receivership Entities has benefited from the identified services.


3. As of the date of the preparation of this Declaration, I have recovered approximately \$2,211,780.02 during the course of my administration of the Receivership Entities, and hold approximately \$2,205,350.02 for the benefit and administration of the Receivership Entities.
