3 **PLEASE TAKE NOTICE** that on July 13, 2023, at 10:00 a.m., or as soon
4 thereafter as this matter may be heard in Courtroom 6D of the above-captioned
5 Court, located at 350 W. 1st Street, 6th Floor, Los Angeles, California 90012, Geoff
6 Winkler (the "Receiver"), the Court-appointed permanent receiver for defendant
7 Essex Capital Corporation and its subsidiaries and affiliates, along with his counsel
8 of record, Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"),
9 and his tax accountant, Miller Kaplan Arase, LLP ("Miller Kaplan," and
10 collectively, with the Receiver and Allen Matkins, the "Applicants"), will jointly
11 submit their sixteenth interim application for the payment of fees and the
12 reimbursement of expenses (the "Fee Application").

13 The Fee Application has been submitted concurrently herewith. Pursuant to
14 the Fee Application, the Applicants seek approval, payment, and reimbursement of
15 their respective fees and expenses incurred during the period from January 1, 2023,
16 through March 31, 2023 (with respect to the Receiver and Allen Matkins) and
17 during the period from May 1, 2022, through March 31, 2023 (with respect to Miller

24 ¹ The Applicants request payment of their fees, on an interim basis, at a reduced
25 80%, with the remaining 20% "holdback" subject to payment at the time of the
26 Applicants' submission of their final fee application in this matter. Accordingly,
27 by the Fee Application, the Applicants request that the Court authorize an interim
28 payment of (a) the Receiver's fees and expenses in the amounts of \$38,135.84
and \$1,338.45, respectively, (b) Allen Matkins's fees and expenses in the
amounts of \$118,847.41 and \$7,302.18, respectively, and (c) Miller Kaplan's fees
and expenses in the amounts of \$18,601.60 and \$0.00, respectively.
